NEW BUSINESS

2. Spoke and Wheel (American Ramp Company) will show a few branding/marketing concepts for the new Skate park/pump track.

John introduces Jason with American Ramp Company. John then presents the 6 design options.

Questions were asked about community input, and the name Basecamp in regards to trademarks and the brewery in Portland.

Discussion ensued.

Will liked option D.

Ryan liked option E.

Alex liked C- likes the colors- thought it had character and was original.

Kim liked option E, thought it was nostalgic, as well as option C.

David liked option C.

Kim added the topo map in option F was a cool trendy feature. Thought it tied into the name Basecamp. Alex agrees.

Don liked option F & C.

Rochelle summarizes the consensus was option C plus the colors of option D.

The group concluded by talking about using the Sandy River or park location topography in option F.

OLD BUSINESS

3. Lango Hansen will review the first Open House and the Council meeting that occurred on March 4th.

Rochelle introduced Deer Pointe.

Brian from Lango Hansen presents a slide deck.

A recap of the council meeting on 3/4 was that pickleball might be a better fit in a community park instead of a neighborhood park. A covered full court basketball court was also mentioned. Option two was the most well received by the council.

The Open house on 3/6 also revealed that option two was the most well liked.

A final comment that was mentioned by Lango Hansen was that a full basketball court would fit in option 2, however specifics would need to be nailed down.

The group then talked about playground equipment based on some options presented by Lango Hansen:

Kim- likes inclusive play.

Don mentioned that climbing play equipment is popular but can have wear and tear issues. He likes the idea of diversity amongst parks.

Kim- Likes diverse playground options- and the combination option presented.

Alex- Likes to have options around the city. Also likes the combination option.

Finally a schedule update is presented.

STAFF UPDATES

Rochelle shares pictures of the demo progress and also the Sandy Bluff Dog Park progress.

Tiana's Updates:

Cedar Creek trail opening is April 6th. The parks team had to do a little storm clean up on the Cedar Creek trail.

The bleachers from the pool sold for \$1600.

The department is harvesting trees from the demo site for Hamilton Ridge Park.

Anti slip treads have been added to Fantasy Forest.

15 trees have been identified on the Tickle Creek trail for removal. The city is beginning to clear Bridge 1 tomorrow. Ant Farm has helped a ton with the Tickle Creek clean up so far. Risks need to be abated before we can reopen Tickle Creek to the public.

John's Updates:

The Senior center's pool table was donated to Ant Farm's new youth center.

The Silent Disco event had almost 50 teens in attendance.

The Mountain Storm jamboree is Saturday.
