RE: Demolition of Aquatic Center and Old Cedar Ridge

To whom it may concern:

O'Malley Brothers Corporation is presenting our bid for the Aquatic Center and Old Cedar Ridge demolitions. Our team of committed employees, from machine operators to office administrators, has a reputation for attention to detail and dedication to environmental protection, quality control, and safety. Our most recent demolition completed in September 2023 was the demolition of a 3,000 square foot house and 17,000 square foot former Tuberculosis Hospital for Reynolds School District. The results were safe, successful demolitions.

The majority of our employees reside in East County – Sandy, Boring, Eagle Creek, Estacada and Gresham. Some of our children attend OTSD schools, and we understand the impact of closing Alt Avenue as the pickup line for Sandy Grade, and being adjacent to the OTA bus hub. We are the generations that swam, and then took our kids, to birthday parties and swim lessons at the Pool. We know the skate park is a recreational area enjoyed by many in the area. We played, and have coached our kids' sports teams inside the middle school gym and sports track down below. We understand the impact this demolition will have on the community, because we will feel it ourselves. However we have also read the 2018 Opsis study, as well as the most recent pool study, seen the future park plans, and know that this is the best option for our community.


Dollars spent toward this demolition will stay local, not taken out of state. You will see us purchasing supplies at Napa and Ace, and have our vehicles and equipment maintained at IDS and Allison Power systems. You'll see our employees eating at Tollgate, Two Brothers, or Smoky Hearth. We'll grab breakfast burritos from Shell, or donuts from Joes, because we know they both make the best of their kind. This year, we held our company team building event at the Sandy Community Center, and enjoyed lunch catered by Sandbar.

Most importantly, we will provide safe and successful demolitions. We did our due diligence spending a combined 100+ hours between our administrative and operations staff learning the buildings' compositions and surrounding land to prepare our bid. We evaluated the ceiling pool beams and hopped in the middle school crawl space, taking laser measurements all around the buildings. We poured over the plan sets to fully understand the scope of work.

We feel prepared to successfully complete this project and are asking the City of Sandy to consider officially accepting our bid based on the Buy Oregon preference. Thank you for your time and consideration.

NEIGHBORHOOD PARKS

Neighborhood parks provide close-to-home recreation opportunities, primarily for passive and non-organized recreation activities.

- Safe and easy access for walking and biking
- Serves multiple user groups within the surrounding neighborhood
- Enhances the geographical dispersion of park features
- Commonly features park amenities like playgrounds, sport courts, and versatile open lawn areas
- Generally 2 to 5 acres in size
- Normally no parking Lots
- Typically no restrooms
