9. Public Hearing To Receive Input from the Public for the Proposed San Juan County Commission and School Board Redistricting Maps

Bill Cooper presented maps for the Commission and School District boundaries. Leonard Gorman from the Navajo Nation submitted maps for commission and the school board districts. James Francom of the Clerk/Auditor office also included a map. Significant discussion ensued regarding the different maps.

The Chapterhouses will receive a form for the Chapterhouse members to give input into the redistricting process. The deadline for return of the form is December 15, 2021. On December 21, 2021, the Commission will vote for a Commission boundary map and a School Board boundaries map.

Terry Noffsinger - lives east of Monticello. Terry asked if the Commissioners were aware of the Department of Justice Civil Rights Act. He felt the maps showed gerrymandering

occurring in the proposed maps.

Doug Allen - resident of Monticello, Doug recommends open seats for County Commission. Asked why Native American percentages are set so high in two commission maps.

Megan Gallegos - resident of Monticello. Megan recommended the Clerk/Auditor map and asked why the 54% Indigenous in another district as deemed insufficient.

Jeff Begay - resident of Navajo Mountain. Jeff wants equitable districts, but felt Navajo voters have been left out of the voting process. He also recommended the Navajo Nation proposal.
