Frank reported that all spray equipment was being made ready for the season. Frank reported that a general Notice to Control Noxious weeds will be published and posted by April 31st.

Weed Department Report Weed Board Meeting 07/07/22

- After submitting applications for 2 UDAF ISM grants, totaling \$97,000, we received 2 grant revision notices on April 18th from UDAF. These notices said that we are approved for the grants if we resubmit the grants at a reduced amount. The e-mails specified a 15% reduction in our Spray Days grant submittal and a 20% reduction in our San Juan River grant submittal. This reduced our grant request from \$97,000 to \$84,200. After submitting the revised grant applications we were awarded both grants for 2022/2023 spray season. After speaking to the weed supervisor from Grand County and Tooele County I learned that everybody that submitted a grant request had to reduce the grant submittal. Luckily we asked for significantly more funding than the previous year and we ended up with \$3000.00 more funding than last year. The revision notices are included as part of this report.
- Don Andrews returned for the season on May 2nd. I am very happy to have him for a third season as he is a valuable asset. We have not had any application for the second seasonal weed sprayer position. In the event that we do not find an employee Don Andrews and I will do all we can to cover the season.
- We Held our first Spray Days events on May 20th and 21st. On Friday the 20th we distributed herbicide in Spanish Valley, La Sal and Bluff. On Saturday the 21st we distributed herbicide in Blanding and Monticello. We provided Milestone and Glyphosate at each of the locations. We had a stronger turnout in Bluff and La Sal then we have had previously. Blanding and Monticello participation was better than ever. Unfortunately the Spanish Valley giveaway was not attended by anyone. It is clear that we will have to find a way to more directly market this event to the residents of Spanish Valley. Perhaps a directed mailer would be effective as the Facebook postings were not. We will have a second event later in the summer as well. We may not distribute in Spanish valley unless we can find a better way to get the word out.
- We will be spraying Giant Reed and Phragmites along the San Juan River this year as part of our San Juan River project. We will use a glyphosate that is formulated for use near water sources. In order to do this, this year, I am required to file a Notice of Intent (NOI) with the Utah Pollutant Discharge Elimination System (UPDES) under the Utah Department of Environmental Quality (UDEQ). This is a new requirement for 2022 under rules created by the National Pollutant Discharge Elimination System (NPDES).
- We began this spray season by addressing vegetation control at the various county properties including yards, libraries, senior centers and fire stations. We will spray the Hideout golf course early this season the try to get a handle on the Canada thistle explosion present last year. I believe regular treatment will eliminate this infestation. We will also do vegetation control along and around the airport runways in Monticello, Blanding and Bluff.
