Adjusted Utah County Redistricting Timeline

January 2021

- Verify correct jurisdictional boundaries for each municipality, school board and special service district in Utah County
- Create a working redistricting group for Utah County
- Review and identify precinct boundaries for any needed changes
- The State of Utah will create the Independent Redistrict Commission (IRC); Code: 20A-20-201

February 2021

- Review submitted boundaries from all districts
- Make note and corrections as needed on boundaries and voting precincts
- 2020 Census data posting on February 28, 2001; Code: 2020 Census P.L. 94-171; POSTPONED UNTIL SEPTEMBER
 2021

March 2021

- Make adjustment to district boundaries and update maps and Statewide Vista database
- IRC public hearings to be held; POSTPONED UNTIL SEPTEMBER 2021

April 2021

• The Secretary of State is required to furnish 2020 census data by April 1, 2021; Code: U.S.C. Title 13, Section 141(c); POSTPONED UNTIL SEPTEMBER 2021

May through July

IRC public hearings to be held; POSTPONED UNTIL SEPTEMBER 2021

August

- Last of the IRC hearings no later than August 1, 2021; Code: 20A-20-301(3); POSTPONED UNTIL AFTER OCTOBER OR NOVEMBER OF 2021
- No later than 20 days after the final public hearing, the IRC will prepare (3) different maps for each district;
 Code: 20A-20-301; POSTPONED UNTIL AFTER OCTOBER OF NOVEMBER OF 2021
- Public hearing to present and explain the maps, and for the public comment on maps; Code: 20A-20-303

September

- The Legislature files copy of district shapefile to the Lt Governor; Code: 36-1-103; POSTPONED UNTIL END OF YEAR 2021
- County Clerks receive copy of redistricting boundary from the Lt Governor; Code: 36-1-103.2; POSTPONED UNTIL OCTOBER OR NOVEMBER 2021
- County Clerks create maps of new school board districts and voting precincts and submits them to the state
 Automated Geographic Reference Center (AGRC) for review; POSTPONED UNTIL OCTOBER OR NOVEMBER 2021
- County Clerk will submit (3) map versions to each school board for review; POSTPONED UNTIL OCTOBER OR NOVEMBER OF 2021

October

- Within 30 days of receipt of map/data, the AGRC will review the map for errors; Code: 36-1-103.2(3)(c);
 POSTPONED UNTIL NOVEMBER OR DECEMBER 2021
- The AGRC will submit finding to the Lt Governor who will notify the clerk of findings
- If needed, the county clerk will make corrections and resubmit map to the AGRC
- If district boundaries are correct, the county clerk will establish voting precincts within each district; POSTPONED UNTIL NOVEMBER OR DECEMBER 2021

November

- Within (5) working days after precinct boundaries are approved, submit map to the AGRC and Lt Governor
- The AGRC will review the map and send findings to the Lt Governor; Code: 36-1-103.2(4)(b)

December

• The County Clerk will post the new district maps on the website
