# 1. Discussion on Skate Park Design Concepts

Director John Bradley discussed with the City Council the process the Community Services department has gone through to obtain a design for the proposed skate park. Director Bradley presented survey results from local community members (see attached) and highlighting percentages regarding accessibility and the level of beginner to intermediate of skaters in the area that provided comment. Director Bradley also went over cost estimates for different design concepts for a skate park.

Director Bradley and Manager Beagley discussed with the council and mayor four locations that were recommended by the professional design company: Centennial Park, Orchard Cove Park, Squashhead Park, and Harvest View Sports Park.

Manager Beagley and Mayor Olson discussed the process of ranking projects in the City each year during budget planning meetings and the process moving forward. The designs for the proposed skate park will be considered and ranked with all other projects and needs in the city by the city council in February 2025.

Councilor Adcock stated that the location is more of a concern for him than the budget at this point in time.





- Pros: The most successful parks are those that include a lot of existing amenities, activities, and good traffic flow for self policing. The location seems like it will be the easiest for a majority of the local population to get to. Restrooms, shade structures, and much more available on this site.

- Note: City Council conflict is in NW Corner by Elementary. It might be an option to move existing playground to NW Corner and place Skate Park on the East side of the Park. Multiple options on this piece of property.
- Top left corner is right across from elementary school.
- Current location of playground might be able to be switched to top left corner.
   Then do skatepark here




