### **NEW BUSINESS**

- 1. The Historic Homes Booklet. Board Chair Jones reviewed the parameters of developing a booklet that highlights the historic significance of homes in Santaquin. Board Member Davis has prepared an excel spreadsheet with names. The drive around town was helpful, but it was determined it would be most effective to meet as a work meeting in January and February. Board Member Jackson volunteered to assist recording family members to those who had historic homes in Santaquin.
- America 250 Celebration. Director Bradley mentioned that our nation will be preparing for 250year-old celebration of our constitution. There will be opportunities for Santaquin to participate in events and programs. We will review this briefly each quarter in the upcoming two years to be ready for 2026 events.
- 3. (Added) City Hall Mural. Board Chair Jones discussed a project recommended by Mayor Olson. The project would involve adding a historic mural inside City Hall entrance. Painting traditional paint as well as new laser printing directly on the wall was discussed. It was recommended and approved by the group to develop a mural that advanced by the decade. This project will take some time to prepare and will be added to future agendas to work on. It was also discussed how to best reach our residents to share pictures. Perhaps through the utility bills or invitations offered at Senior weekly meals.
