In pursuant to Wyoming Code; notice is hereby given that a Public Hearing will be held by the Town of Saratoga Planning and Zoning Commission.

**Purpose:** The Town of Saratoga is contemplating the purchase of approximately 2 acres located in the Industrial zoned area within the Saratoga municipal limits. The purpose of the purchase would be to relocate the Public Works Department operating facilities from their current location on River St. to this newly purchased property. The stimulus for purchase is the current conditions. It is assumed the current facilities are inhabiting property that could be utilized to provide a more beneficial use to the community. The structures being currently used are also in need of significant investment with structural members as well as roofs in need of repair. This possible purchase could provide a unique solution to the current conditions. The town is proposing funding the acquisition and construction of the new facilities through USDA financing.
