There were 64 voted ballots, 3 Special Needs Ballots, and 1 Questioned Ballot. There were 54 unused ballots that were destroyed before the ballot box was opened. This accounted for 120 ballots curated by the City Clerk and transferred to the Election Judges on the day of the election.

The included 3 Special Needs ballots. These were certified as valid by unanimous consent of the board. These envelopes were opened and the ballots with the secrecy sleeves were mixed in the ballot box prior to counting.

There was one Questioned ballot that was determined not valid per 2.45.130 Voter qualifications. This voter was not registered in the City of Saxman with the Division of Elections 30 days prior to the election.


