## Election Officials Report October 2, 2024

---

City of Saxman Canvass Board:

The 2024 Regular City Election was held October 1, 2024 at City Hall. Polls were open starting at 7:00am and closed at 8:00pm.

The Election Official was Marissa Medford, City Administrator. The Election Chair was Melissa Fuller, Administrative Assistant. Tempa Major and Florence McGilton served as Election Judges.

The Election Official, Chair, and Judges took and signed the Oath of Office for Election Board Workers and read and signed the Division of Elections Confidentiality Agreement Regarding Voter Registration Information.

The Receipt of Ballots and Preliminary Election Results were certified.

The preliminary ballot count was started at 8:05pm and concluded at 8:45pm. The results are as follows:

- **Seat 1:** Frank H. Seludo with a total of 31 votes received
  - There were 6 write-ins for Seat 1 with a total of 1 vote received by each
- **Seat 3:** Richard H.K. Makua with a total of 28 votes received
  - There were 5 write-ins for Seat 3 with a total of 1 vote received by each
- **Seat 5:** William "Billy Joe" Thomas with a total of 24 votes received
  - There were 6 write-ins for Seat 5 with a total of 1 vote received by each

The Election Official read the ballots out loud and the Election Chair and both Election Judges tallied the preliminary ballot count. The tallied preliminary ballot count was the same across all tally sheets and only took one count. No public was present for the preliminary ballot count.

- Absentee Ballots Cast: 1
- Special Needs Ballots Cast: 1
- Questioned Ballots Cast: 3
- Regular Ballots Forwarded to Canvass Board for Determination: 3\*
  - \*Election Judges did not tally these ballots to the preliminary results and are pending determination on how to proceed from the Canvass Board on Friday, October 4, 2024 at 5pm.
