# KETCHIKAN GATEWAY BOROUGH RESOLUTION NO. 2905 CITY OF KETCHIKAN RESOLUTION NO. 21-2816 CITY OF SAXMAN RESOLUTION NO. 8.24.05

A JOINT RESOLUTION OF THE ASSEMBLY OF THE KETCHIKAN GATEWAY BOROUGH, COUNCIL OF THE CITY OF KETCHIKAN, AND COUNCIL OF THE CITY OF SAXMAN RECOGNIZING FIRE CHIEF AND INCIDENT COMMANDER ABNER HOAGE AND HIS SERVICE TO THE COMMUNITY OF KETCHIKAN; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the Ketchikan Gateway Borough Assembly, Ketchikan City Council, Saxman City Council, and community of Ketchikan recognize the service, contributions, and dedication of City of Ketchikan Fire Chief and Incident Commander Abner Hoage and congratulate him on his retirement, effective October 15, 2021; and

**WHEREAS**, Chief Hoage was raised in Tumwater, WA and graduated Tumwater High School one year early to join the United States Air Force in 1992 with authorization from his parents; and

WHEREAS, while initially wanting to be a pilot, Chief Hoage entered the Air Force under the fire department where he quickly committed himself to the world of fire service; and

WHEREAS, Chief Hoage was first stationed at nearby McChord Air Force Base and was soon deployed overseas and later stationed at Eielson Air Force Base near Fairbanks, Alaska where he met his wife Robyne; and

WHEREAS, through his service in the Air Force, Chief Hoage was stationed at Lajes Field in the Azores, Portugal, Ramstein Air Force Base in Germany, Elmendorf Air Force Base in Alaska, McGuire Air Force Base in New Jersey, Soto Cano Air Base in Honduras, and Mountain Home Air Force Base in Idaho, over which time period he quickly advanced ranks in a variety of fire service units and operations; and

**WHEREAS**, while serving in the Air Force, Chief Hoage completed his Masters of Management and Public Administration, which would serve him well when he retired from the Air Force in 2012; and

**WHEREAS**, wishing to apply his service talents in the civilian world, Chief Hoage served as Fire Chief for the City of Unalaska from 2012 to 2014, and was then appointed as City of Ketchikan Fire Chief in 2014; and

WHEREAS, Chief Hoage has brought about lasting changes for the City of Ketchikan and community, including regular coordination with local and state fire, emergency and law enforcement agencies, upgrades to the local radio and dispatch systems, initiating the Nixle Alert System for residents, developing a comprehensive fire apparatus replacement program, expanding the tsunami alert system, enhancing local emergency preparedness and response, and securing many grants to support departmental and emergency operations and initiatives; and

WHEREAS, Chief Hoage has served as a the Emergency Manager for the Ketchikan Gateway Borough and City of Ketchikan and has been involved with the Local Emergency Planning Committee, the Alaska Council on Emergency Medical Service, and served as President of the Alaska Fire Chiefs Association. He has continued to stay up-to-date on the latest innovations and approaches to emergency and disaster prevention, management, response, and recovery; and

- WHEREAS, Chief Hoage is a well-respected community leader that has the keen ability to recognize others' strengths and has provided mentorship and encouragement to bring out the best in his team members for the good of the Ketchikan Fire Department and the community; and
- **WHEREAS**, Chief Hoage's skills in leadership and emergency management were evidenced most profoundly in his position as Incident Commander for the Ketchikan Emergency Operations Center throughout the entirety of the COVID-19 pandemic beginning in March of 2020; and
- WHEREAS, as Incident Commander, Chief Hoage was the face of Ketchikan's pandemic response and adeptly coordinated with multiple local, state and federal agencies; and
- **WHEREAS**, through his development of a strong and extremely capable COVID-19 emergency management team, Chief Hoage carried Ketchikan through an unprecedented public health disaster with diplomacy, professionalism and positivity, to which Ketchikan owes a great debt of gratitude; and
- WHEREAS, Ketchikan has surely become a safer, better prepared community due to the efforts of Chief Hoage, and Chief Hoage will long be remembered as one of the more exceptional, committed professionals Ketchikan was so fortunate to have as a resident, colleague, and friend; and
- **WHEREAS**, Chief Hoage will retire to the lower 48 to travel and spend time with family. The Ketchikan Gateway Borough Assembly, Ketchikan City Council and Saxman City Council wish Chief Hoage a well-deserved retirement and hope the best for him and his family in their future endeavors.
- **NOW, THEREFORE, BE IT RESOLVED** by the Assembly of the Ketchikan Gateway Borough, Council of the City of Ketchikan, and Council of the City of Saxman as follows:
- **Section 1.** The Ketchikan Gateway Borough, City of Ketchikan and City of Saxman do hereby extend sincere thanks and congratulations to Chief Hoage as well as to his family.
- <u>Section 2.</u> The Ketchikan Gateway Borough, City of Ketchikan and City of Saxman recognize and celebrate the many contributions made by Chief Hoage in his nearly 7 years of service to the City of Ketchikan Fire Department and greater Ketchikan community.
- <u>Section 3.</u> The City of Ketchikan shall transmit a duly certified copy of this resolution to Chief Hoage in expression of appreciation.

6. Alaska-British Columbia Transboundary Salmon Rivers

Background: Canada continues to permit massive mines with toxic tailings dams along shared rivers without the meaningful engagement of those of us downstream. Meanwhile, transboundary salmon runs plummet. The Southeast Alaska Indigenous Transboundary Commission (SEITC) and Salmon Beyond Borders humbly request that the City of Saxman Council consider adopting a municipal resolution based on the attached Resolution of Support language that has been carefully drafted, considered, and signed by many of our closest transboundary partners who represent multiple sectors and interests of Southeast Alaska.

8. Pay Part-time Employees Holiday Pay

Background: The City Administrator would like to address the Council about amending the Personnel Policy to include that part-time personnel get paid for holidays. As it is now we employ 2 part-time positions that accomplish the work of working full time hours. When there is a paid holiday the City Administrator is allowed paid leave, but if the part-time employees don't want to loose any money in their pay checks they feel compelled to work the holiday. I believe this just results in a decrease in production since City Hall is not open and the City Administrator is supposed to be on holiday. The City can't afford benefits to these 2 employees, but it could afford paying them for holiday's while allowing them to have off time without the stress of missing pay. It is a small thing for the City but would show appreciation to the part-time employees. This would only include employees that were done with their 90 day probation.

# Administrator's Report September 15<sup>th</sup>, 2021

# City Council:

An update on D. Markel the Finance Clerk: She has returned to her regular schedule with reasonable accommodations made. The City still needs to look at installing an automatic door opener to support her return to work in a wheel chair.

B. Berg has been running the latest sub-award grant from OVS. She has done a great job at qualifying applicants and distributing cards to approved applicants. Brianna is also setting up the grant for Walmart cards for residents that have been negatively affected by CoVid19. OVS has agreed to pay an administrative fee to cover costs associated with running these grants. I would like to look into using some of that fee to give a bonus to Brianna for the extra work she has been doing.

We have hired John Denny to learn how to run the water treatment plant. Richard Shields is training him. When the Chlorine pump failed we substituted the polymer pump and are now hand diluting and missing the polymer. This is not easy and the Mayor and I have spent a lot of hours in the plant this last month supporting Richard and John with the chemical and operation of the plant. We are all agreed that there is a significant leak, or leaks, somewhere in the distribution line and are taking steps to find them.

The Mayor and I will take the Level One operator class in October. John Denny will take the small water treatment plant class when they host the next one.

The election is set to take place October 5<sup>th</sup> and the polling place will be upstairs this year to allow for social distancing.

Bri deserves a big thank you for how fast she has picked up on things and all the extra work that went into running the OVS grants.
