Alleged Ethics Violation prepared by Attorneys Mark Kapocius and Laurie McLeRoy of von Briesen & Roper which was shared in a closed session of the Ethic's Board on March 17, 2025, and with redacting the identities of certain City employees interviewed based upon the balancing test, including the public's strong interests in avoiding the detrimental impact on conducting future investigations, protecting cooperating employees from retaliatory and other negative actions, protecting from the negative impact on City personnel morale, and the chilling effect such a disclosure might have on employees' willingness to participate in internal investigations in the future, among other reasons identified by the records custodian. The limited waiver would extend only to the ten-page report itself and would not extend to any other privileged communications.
