ORDER

For the reasons stated herein, the Complainant's Petition for Writ of Certiorari in the above captioned matter is hereby **DENIED**.

In <u>State ex rel. City of Waukesha v. City of Waukesha Board of Review</u>, 201 WI 89, par. 18, 399 Wis.2d 696, 706-07, 967 N.W.2d 460, the Wisconsin Supreme Court gave its most recent affirmation of the legal standards for a circuit court in assessing a Petition for Writ of Certiorari:

On certiorari review, the reviewing court's inquiry is narrow. It is limited to the record before the board and addresses only whether the board's actions were: (1) within its jurisdiction; (2) according to law; (3) arbitrary, oppressive, or unreasonable and represented its will and not its judgment; and (4) supported by evidence such that the board might reasonably make the order or determination in question.

In applying the above standards to the case at bar:

First, was the Complaint brought by Petitioner within the jurisdiction of the City of Sheboygan Board of Police & Fire Commissioners (the "BOARD")? The answer is yes. No one involved disputes this issue.

Second, did the Board proceed according to the law? The court answers this question in the affirmative and finds this issue to be dispositive. The Board followed all the procedural rules detailed in responding to a citizen's complaint. The Board found that the Complainant filed 37 -days after the deadline set by local rule. This finding is not disputed by the Complainant. The Complainant asks this court to interpret "SHALL be filed with the Board no later than ten (10) days following receipt of the written disposition" to "MAY be filed...." See the Board's "Consolidated Decisions and Orders, page 2. Because there is no ambiguity in the Section 4 of the Board's Policies and Procedures, the court cannot engage in statutory interpretation. Therefore, shall means shall and a 37 day violation of the 10 day rule is clearly grounds for the Board to dismiss the Complaint in its entirety.

Since the Board was well within its right to dismiss the Complaint in its entirety, the court need not address any other issues raised by the Complainant.¹

¹ The court notes that the Board's decisions relating to the John Doe proceeding leave open the Complainant's right to bring a supplemental complaint depending upon the results of the John Doe proceeding. See Board's "Consolidate Decisions and Orders", p. 6 and 8.
