4. Discussion of the extension request for the armory documentary.

Chad Pelishek discussed the complications with getting the armory documentary edited. The current plan is for Scott Mealiff with WSCS to complete this project by mid-October. The commission should be able to view a draft of the documentary in October before the public viewing later in the year.

5. Discussion of an Architectural Intensive Survey not being required at this time.

Chad Pelishek gave a background on the Architectural Intensive Survey, its uses, and the last time a survey was complete between 2002 and 2006. At this time a new survey is not required to update the City's programmatic agreement, and the Wisconsin Historical Society does not think the current survey is old enough to warrant a new survey at this time. The survey update performed by Traci Schnell can be used to amend the current survey.

Peter Mayer suggested considering an ordinance update to provide more guidance to the commission and prevent government overreach. He suggested this may help persuade some individuals to have their homes listed in the National Register of Historic Places.

6. Other Historical Preservations matters to be discussed.

Travis Gross suggested that the historical walks he leads for the neighborhood associations be made public through an app. This may serve as an educational tool for the public to learn about local history and get information out to the community.
