City Attorney Adams discussed the general duties of the committee and the various types of licenses the committee will be dealing with, and also other matters the committee will

handle, including ordinance changes, quasi-judicial hearings on suspension/revocation of licenses, and matters referred to the City's ethics board. CA Adams pointed out that the State of Wisconsin recently allowed most licenses to be approved by the Clerk rather than coming to the Common Council, so that is why not all license applications appear on the R.O.'s issued by the Clerk.

8. Presentations by potential applicants for available "Class B" alcohol beverage licenses

There is presently one "Class B" alcohol beverage license available. Maria Pavon and Ricardo Pavon, Bailey Kupfer, Nicole Milligan, and Irma Valdez all appeared before the committee to again present their cases regarding pre-application for the available license. All four businesses had also made presentations at the April 13, 2022 meeting.

Maria Pavon and Ricardo Pavon spoke on behalf of Cocina Mi Familia located at 1423 Union Avenue (formerly El Durango). They have owned the business since August 2021 and serve authentic Mexican food. They feel a liquor license would enhance the dining experience. Capacity is presently 80. They are actively renovating and transitioning to the new name. An outdoor dining patio may be added in the future. Mr. Pavon indicated that having a liquor license would also allow them to extend their business hours each day.

Bailey Kupfer spoke on behalf of the Watershed Hotel at 838 North 15th Street on the river. They plan to open on July 1st. This boutique hotel will have 25 rooms and an outdoor event space with a capacity of 200. They estimate 20 to 30 weddings per year during the warmer months. The inside bar has a capacity of 39 and will be open 5-11 p.m. seven days a week. Ms. Kupfer discussed the room tax benefits to the City and stated that without a liquor license they might not be able to book as many weddings because dry weddings are not as popular.

Alderperson Dekker joined the meeting at 4:40 p.m.

Nicole Milligan spoke on behalf of Harbor Petroleum, 905 Indiana Avenue. A bar and restaurant will be located on the other side of the gas station. Capacity will be around 50 and they should be ready to open in approximately two months. The majority of income will come from the food served which will include Indian food. There will also be gambling machines.

Irma Valdez spoke on behalf of Bar 9 located at 1034 Michigan Avenue. They have be renovating since February 2021 and the bar area is now ready. The restaurant area is almost ready. The bar is primary and the restaurant is secondary. Occupancy is currently 50 and that will increase to 75 when food is served. It will be primarily Mexican food and also bar food. Ms. Valdez indicated that Bar 9 purchased the bar with a liquor license but due to a misunderstanding lost that license as a result of the continuation of business ordinance.

Gen. Ord. No.  $\sqrt{-22-23}$ . By Alderpersons Felde and Ackley. May 16, 2022.

AN ORDINANCE amending the rules contained in Sec. 74-56 of the Municipal Code regarding alcohol possession and consumption in parks so as to more clearly provide for possession and consumption of beer and wine while maintaining a prohibition on liquor.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. Sec. 74-56 of the Municipal Code entitled "Alcohol possession/consumption" is hereby repealed and recreated in subsections (e) and (f) thereof so as to read as follows:

"Sec. 74-56. - Alcohol possession/consumption.

. . .

- (e) A group or organization that has a temporary Class "B" or a temporary "Class B" alcohol "picnic" license may also serve and permit the consumption of fermented malt beverages and of wine in any city park, subject to the terms of the license, and subject to subsection (f) below.
- (f) If any group or organization serves fermented malt beverages or wine at any event pursuant to a permit issued under section 74-42, no person shall, during the course of the event, carry into the park plastic containers, glass bottles or metallic cans containing alcoholic beverages, except the sponsor of the event, who may transport kegs, barrels, bottles, or cans into the park for the purpose of serving fermented malt beverages and/or wine.
