## 7. Tsubame

### MEAD LIBRARY DISPLAY

A) Purpose: To celebrate the Sheboygan -Tsubame sister city relationship while promoting the Children's Letter/Artwork/Video Exchange and sharing the Beauty & Culture of Japan.

### B.) Themes

- 1.) The display celebrates the 25-year relationship of Tsubame and Sheboygan.
  - 2.) The central focus is the Children's Letter/Artwork/ Video exchange featuring samples of letters, artwork & video from Tsubame students complimented by explanatory text, photos and video of Longfellow students engaged in the exchange activities.
  - 3.) Official Civic Commemoratives & Gifts will illustrate the origin & exchanges between the two sister cities.
  - 4.) The Beauty and Culture of Japan with an emphasis on children will be showcased with a small collection of art & objects collected from locals with family connections to Japan. As an example, colorful carp kites, kimonos and a long plush kitty will provide a child-appealing backdrop. A tea set, dolls, fans a silk-painting, masks, comic book, chopsticks and more will delight the eye.
- C. Color Scheme & Physical Display: To set-off the vibrant display of objects, letters, artwork & photos the backdrop will be a neutral off-white hand-woven piece by local textile artisan Sherri Vandenberg.

Signage will be on White cardstock with Black ink.

The predominant grounding color & accents are yet to be determined by the assemblage of objects.

Plexiglass boxes, glass shelving and holders along with covered boxes will be used to give interest, height & depth to the collection.

D.) Budget: My husband Jim and I will donate the funds to cover signage (\$87.15) and photo printing (\$25)

E.) Assembly & Tear-down: Friday March 8 the display will be assembled at Mead Library. I expect it will take 6 hours.

The display will be taken down on March 29.

Coffee talks are currently on hold with Tsubame. We would like support on etiquette training. Tomomi, Minimi and Jon can assist with etiquette training.

When the Tsubame delegation arrives, Tomomi suggested we play GaGa Ball. Tomomi Brittany, and Annie would like to see the itinerary.
