# Wednesday, March 16, 2022

#### **OPENING OF MEETING**

**MEMBERS PRESENT:** Travis Gross, Peter Fetterer, Paul Gottsacker, Peter Mayer, and Carolynn Lee **STAFF/OFFICIALS PRESENT:** Planning & Development Director Chad Pelishek

1. Call to Order

Chair Travis Gross called the meeting to order.

3. Approval of minutes from the January 19, 2022 meeting.

#### ITEMS FOR DISCUSSION AND POSSIBLE ACTION

4. Discussion and possible action on Certificate of Appropriateness for the former Sheboygan Press building at 632 Center Avenue.

Kim Trent and Ali Kopyt presented the plans for renovations at the former Sheboygan Press building at 632 Center Avenue to convert the building into a 29 unit apartment complex including replacing the windows with like windows and a garage door with one closer to the original garage doors of the building.

The commission inquired about the exterior details and what will remain intact.

Kim Trent and Ali Kopyt stated that anything not in the application will not be altered and the renovation will follow the Secretary of the Interior's Standards for the Treatment of Historic Properties.

Motion by Peter Mayer, seconded by Peter Fetterer to issue a Certificate of Appropriateness as applied for, subject to the additional requirement that other than changes identified in the application, no exterior building features or components are removed or altered, including without limitation window ledges, ornamental reliefs and Sheboygan Press identification signs, and that nomination papers for National Register be provided to the Commission. Motion carried.

5. Presentation by Jason Tish, Certified Local Government and Preservation Education at the Wisconsin Historical Society.

Jason Tish, Certified Local Government and Preservation Education at the Wisconsin Historical Society presented information regarding Sheboygan as a CLG, what is known about eligible historic properties in Sheboygan, and what other CLGs and commissions do, including opportunities for grant funding from the Wisconsin Historical Society.

The Commission discussed the need to educate property owners on the benefits of nominating historical properties and how grant funding may be used for education to result in more nominations.
