CITY OF SHEBOYGAN ORDINANCE 28-23-24

BY ALDERPERSONS SALAZAR AND FELDE.

OCTOBER 23, 2023.

AN ORDINANCE amending various sections of the Sheboygan Municipal Code with regard to contractor licensing, including the removal of a codified fee schedule.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

SECTION 1: <u>AMENDMENT</u> "Sec 12-125 Classification" of the Sheboygan Municipal Code is hereby *amended* as follows:

AMENDMENT

Sec 12-125 Classification

Contractors are classified and the licenses/registration fees for such contractors <u>shall be as set</u> forth in the Contractor's Licenses Fee Schedule on file in the offices of the city clerk and <u>building inspectionare established as set forth below</u>. Licensed or registered contractors may perform only the particular type of work or services specified by the particular classification:

- (a) General contractor.
 - (1) General contractors may perform residential and commercial building and remodeling, including the following:
 - a. Rough framing;
 - b. Insulating;
 - c. Drywall;
 - d. Roofing;
 - e. Siding;
 - f. Building component insulation;
 - g. Steel erecting;
 - h. Building of fences, porches, and decks; and
 - i. In-ground pool installation.
 - (2) The permitted activities include both structural and nonstructural work.
 - (3) The following activities are not included among the work that may be performed by general contractors:
 - a. Heating, ventilating, and air conditioning;
 - b. Plumbing; and
 - c. Electrical.
- (b) Carpenter contractor.
 - (1) Carpenter contractors may perform residential building and remodeling,

including the following:

- a. Rough framing;
- b. Insulating;
- c. Drywall;
- d. Roofing;
- e. Siding;
- f. Building component insulation;
- g. Steel erecting; and
- h. Building of fences, porches, and decks.

The permitted activities include both structural and nonstructural work.

- (2) Carpenter contractors may engage in building and remodeling of commercial buildings covered under the International Building Code and Wis. Admin. Code chs. SPS 50--70, including the following:
 - a. Interior nonstructural remodeling;
 - b. Remodeling, removal, and building of non-load-bearing walls, nonstructural windows, and nonstructural doors;
 - c. Siding;
 - d. Roofing; and
 - e. Construction/repair of fences.
- (3) The following activities are not included among the work that may be performed by carpenter contractors:
 - a. Heating, ventilating, and air conditioning;
 - b. Plumbing; and
 - c. Electrical.
- (c) Carpenter accessory contractor.
 - (1) Carpenter accessory contractors may engage in building and remodeling of residential accessory buildings, including detached garages, decks, pergolas, sheds, and gazebos, as defined in sections 30.20 and 30.21 of the Uniform Building Code, including the following:
 - a. Rough framing;
 - b. Insulating;
 - c. Drywall;
 - d. Roofing:
 - e. Siding;
 - f. Building component insulation;
 - g. Steel erecting; and
 - h. Building of fences.

The permitted activities include both structural and nonstructural work.

- (2) The following activities are not included among the work that may be performed by carpenter accessory contractors:
 - a. Building and remodeling of commercial or primary residential buildings;
 - b. Heating, ventilating, and air conditioning;
 - c. Plumbing; and
 - d. Electrical.
- (d) Registered contractor.

- (1) Registered contractors within each classification below may perform only work within its classification:
 - a. Drywall installation;
 - b. Insulation;
 - c. Masonry/concrete;
 - d. Moving/razing;
 - e. Roofing;
 - f. Siding.
 - g. Nonstructural building component installation, including, but not limited to:
 - 1. Windows, doors.
 - 2. Cabinets, countertops.
 - 3. Fencing.
 - 4. Steel erecting.

SECTION 2: <u>AMENDMENT</u> "Sec 12-126 Applications" of the Sheboygan Municipal Code is hereby *amended* as follows:

AMENDMENT

Sec 12-126 Applications

An applicant for a contractor's license or registration shall make application by filling in the printed forms which may be obtained from the building inspection division and paying an \$25.00 application fee per license or registration.

SECTION 3: <u>AMENDMENT</u> "Sec 12-130 License/Registration Fee" of the Sheboygan Municipal Code is hereby *amended* as follows:

AMENDMENT

Sec 12-130 License/Registration Fee

Before any license or registration shall be issued or renewed under the provisions of this division, the applicant shall pay a license or registration fee as follows: set forth in the Contractor's Licenses Fee Schedule on file in the offices of the city clerk and building inspection.

(a) General contractor license: \$300.00. Carpenter contractor license: \$150.00. Registered contractor: \$100.00. Business owner contractor: \$100.00.

SECTION 4: <u>AMENDMENT</u> "Sec 12-133 Temporary Licenses" of the Sheboygan Municipal Code is hereby *amended* as follows:

AMENDMENT

Sec 12-133 Temporary Licenses

- (a) Any contractor, before commencing any type of construction contracting work shall first apply for a license to engage in such contracting work. Such application shall be made to the <u>director of planning eity planner</u> or <u>their</u> designee, who may issue a temporary license to such contractor for a specific contracting job, upon the applicant's furnishing proof of compliance with the insurance/bonding requirements of section 12-132, the required qualifications of section 12-127 and upon payment of the required permit fee as <u>set forth in the Contractor's Licenses Fee Schedule on file in the offices</u> of the city clerk and building inspection, <u>follows:</u>
 - (1) Temporary earpenter: \$250.00. Temporary general: \$525.00. Temporary registration: \$200.00. Temporary heating contractor: \$125.00.
- (b) In the event the application for a temporary license is denied, the applicant may appeal to the board of examiners within five days after the denial, such appeal to be in writing and shall set forth the ruling appealed from and be filed with the secretary of the board of examiners. Such notice of appeal shall state clearly and briefly the grounds of the appeal. Where a situation requires an immediate decision, that of the city planner or the planner's designee shall be final and conclusive.
- (c) No more than two such temporary licenses shall be issued to any one contractor/business within a calendar year.

SECTION 5: <u>AMENDMENT</u> "Sec 12-347 Temporary Licenses" of the Sheboygan Municipal Code is hereby *amended* as follows:

AMENDMENT

Sec 12-347 Temporary Licenses

- (a) Any contractor, commencing any type of heating, ventilating or air conditioning work within the city shall first apply for a contractor's license to engage in such contracting work. Such application shall be made to the heating inspector, who may issue a temporary license to such contractor for a specific contracting job, upon the applicant's furnishing proof of compliance with the insurance requirements of section 12-343, meeting experience qualifications of section 12-341, and upon payment of a temporary license fee of \$50.00.
- (b) If the application for a temporary license is denied, the applicant may appeal to the board of examiners within five days after the denial, such appeal to be in writing and shall set forth the ruling appealed from and be filed with the secretary of the board of examiners. Such notice of appeal shall state clearly and briefly the grounds of the appeal. Where a situation requires an immediate decision that of the manager of planning and inspection services or the manager's designee shall be final and conclusive.
- (c) Nothing in this section shall prohibit a contractor whose principal place of business is located outside of the city from obtaining a contractor's license pursuant to this division.
- (d) No more than two such temporary licenses may be obtained by any one contractor in a 12-month period.

(1) Registered contractors within each classification below may perform only work within its classification:

- a. Drywall installation;
- b. Insulation;
- c. Masonry/concrete;
- d. Moving/razing;
- e. Roofing;
- f. Siding.
- g. Nonstructural building component installation, including, but not limited to:
 - 1. Windows, doors.
 - 2. Cabinets, countertops.
 - 3. Fencing.
 - 4. Steel erecting.

- (b) In the event the application for a temporary license is denied, the applicant may appeal to the board of examiners within five days after the denial, such appeal to be in writing and shall set forth the ruling appealed from and be filed with the secretary of the board of examiners. Such notice of appeal shall state clearly and briefly the grounds of the appeal. Where a situation requires an immediate decision, that of the city planner or the planner's designee shall be final and conclusive.
- (c) No more than two such temporary licenses shall be issued to any one contractor/business within a calendar year.

- (b) If the application for a temporary license is denied, the applicant may appeal to the board of examiners within five days after the denial, such appeal to be in writing and shall set forth the ruling appealed from and be filed with the secretary of the board of examiners. Such notice of appeal shall state clearly and briefly the grounds of the appeal. Where a situation requires an immediate decision that of the manager of planning and inspection services or the manager's designee shall be final and conclusive.
- (c) Nothing in this section shall prohibit a contractor whose principal place of business is located outside of the city from obtaining a contractor's license pursuant to this division.
- (d) No more than two such temporary licenses may be obtained by any one contractor in a 12-month period.
