5. IHO process information

Attorney Hagen explained the Independent Hearing Officer role and how IHOs can assist Police and Fire Commissions during a hearing process. The PFC is able to determine when they would like to call upon an IHO to assist them. The IHO would go through the evidentiary portion on behalf of the commission and would synthesize and present information from the hearing to the PFC for their decision.

Establishing commission rules and regulations

Attorney Hagen generally explained the roles of rules and regulations for PFCs. There was discussion regarding residency requirements for non-rep personnel and job descriptions with Attorney Hagen.

The PFC requested that the Fire Chief, Police Chief, City Administrator, and HR Director review a sample rules and regulations document provided by Attorney Hagen and make recommendations and suggestions to the PFC at the August 2025 regular meeting.
