Submitting Findings of Fact and Conclusions of Law based upon testimony and exhibits presented at a Quasi-Judicial Hearing held on August 25, 2025 regarding the licenses held by J.N. Cortez LLC, D.B.A. Mi Ranchito II (License #3475) in the City of Sheboygan.

The Committee recommends that the Common Council of the City of Sheboygan take the following actions:

- 1- Revoke Dancehall License number 3475.
- 2- Suspend Class "B" and "Class B" license number 3475 for a period of 90-days for maintaining a disorderly or riotous house in violation of § 125.12(2)(ag)2., Wis. Stats.
- 3- Suspend Amusement License number 3475 pursuant to Sheboygan Municipal Code 6-221 for a period of 90-days because the Licensee's establishment has become a source of rowdiness in the neighborhood, a source of frequent complaints to police, and a disruption to good peace and order.

LICENSING, HEARINGS, AND PUBLIC SAFETY COMMITTEE REPORT

On August 14, 2025, a Summons was issued to J.N. Cortez, LLC D.B.A. Mi Ranchito II (the "Licensee") for the licensed premises located at 1235 Indiana Avenue, Sheboygan, WI (the "Premises") based upon a sworn written Complaint signed August 14, 2025 by City of Sheboygan Patrol Officer Gustavo A. Lopez. A sworn written Amended Complaint was signed August 20, 2025 by Chief of Police Kurt Zempel. The Amended Complaint included five counts against the Licensee and sought the revocation of the Licensee's Class "B" fermented malt beverage license, "Class B" intoxicating liquor license pursuant to §§ 125.12(2)(ag)1. and 2., Wis. Stats. and Sections 4-3 and 4-34 of the Sheboygan Municipal Code. The Amended Complaint also sought the revocation of the Licensee's Dancehall license pursuant to Sections 6-57 and 6-83 of the Sheboygan Municipal Code and the revocation of Licensee's Amusement license pursuant to Section 6-221 of the Sheboygan Municipal Code. The Amended Complaint was served on the licensing agent, Elena Goya Cortez, on August 20, 2025. All references to the "Complaint" shall be to the Amended Complaint dated August 20, 2025.

On August 25, 2025, the City of Sheboygan Licensing, Hearings, and Public Safety Committee (the "Committee) held a hearing on the Amended Complaint. The Complainant was represented by Attorney Nicholas Cerwin. The Licensee appeared by licensing agent Elena Goya Cortez, and was represented by Attorney Jason E. Dierkes. The Committee was represented by Attorney Ian Prust.

Findings of Fact

Based upon the testimony and exhibits presented by Complainant and Licensee the Committee makes the following Findings of Fact and Conclusions of Law.

Count 1 – 7/10/2025 Closure of Establishment

Based upon the testimony of Sheboygan Building Inspector Michael Cupp, the Committee finds the facts set forth in Count 1 of the Complaint to be true. Based upon safety concerns regarding the structural integrity, the Mi Ranchito Premises are currently unsafe for occupancy and have been placarded by the City of Sheboygan.

Conclusions of Law:

Revocation or Suspension of Class "B" and "Class B" license number 3475 pursuant to § 125.12(2)(ag)1., Wis. Stats., and Sheboygan Municipal Code 4-3: The structural issues set forth in Count #1 are not a legal basis for the revocation of the Licensee's Class "B" and "Class B" alcohol licenses.

Revocation of Dancehall License number 3475: The Committee recommends that the Dancehall license issued by the City pursuant to Sheboygan Municipal Code 6-86 held by J.N. Cortez, LLC D.B.A. Mi Ranchito II be revoked for failure to keep the premises in compliance with building laws, ordinances, and rules related to maintaining a proper place to hold dances as required by Sheboygan Municipal Code 6-83.

Counts 2, 3, and 5 – Relating to a Shooting Incident and Various Physical and Nuisance Incidents

Based upon the testimony provided by Officer Gustavo Lopez-Villaneueva in support of Counts 2 and 3, Officer Charles Jumes in support of Count 3, and Officer Chris Strzyzewski in support of Count 5, and based upon the testimony provided by Elena Goya Cortez, the committee makes the following findings regarding Counts 2, 3, and 5 of the Complaint:

- 1- The Committee finds the testimony of the City of Sheboygan police officers to be credible and accurate representations of the events that occurred on the Premises as set forth in Counts 2, 3, and 5 of the complaint.
- 2- Based upon the testimony of the City of Sheboygan Police Officers, the Committee finds the allegations set forth in Counts 2, 3, and 5 of the complaint to be true.
- 3- The Committee finds that the facts and circumstances set forth in Counts 2, 3, and 5 demonstrate a pattern of Licensee's repeated failure to properly and timely notify the Sheboygan Police Department of significant incidents which caused disorderly and riotous behavior at the premises. The result of these incidents endangered public safety.
- 4- The Committee finds that the Licensee's failure to properly and timely notify the Sheboygan Police Department of incidents at the premises resulted in additional disorderly and riotous behavior which originated at Mi Ranchito and continued at off-premise locations, further endangering public safety.

- 5- The Committee finds that Count 3 is a significant violation of § 125.12(2)(ag)2., Wis. Stats. The Committee finds that Juan Negrete a co-owner of the Licensee was an active participant in the physical altercation on January 18, 2025. The Committee further finds that Elena Goya Cortez failed to properly disclose the identity of the participants in the physical altercation specifically, that she did not identify Juan Negrete as a participant in the altercation until after Mr. Negrete was unavailable for questioning for an extended period of time. These findings related to Count 3 demonstrate that the licensee has maintained a disorderly or riotous premises which endangers public safety.
- 6- The Committee finds that the police calls set forth in Count 5 specifically those set forth in Paragraphs 15.a, b., and c. of the Complaint support the pattern of failing to notify the Sheboygan Police Department in a timely manner of activities which cause disorderly and riotous behavior at the Premises and off the Premises, in violation of Wis. Stat. § 125.12(2)(ag)2.

Conclusions of Law:

Revocation or Suspension of Class "B" and "Class B" license number 3475 pursuant to § 125.12(2)(ag)2., Wis. Stats., and Sheboygan Municipal Code 4-34: Based upon the Committee's findings regarding the activities set forth in Counts 2, 3, and 5 of the Complaint, the Licensee keeps or maintain a disorderly or riotous house. The Committee recommends a 90-day suspension of the Class "B" and "Class B" licenses held by J.N. Cortez, LLC D.B.A. Mi Ranchito II.

Revocation or Suspension of Class "B" and "Class B" license number 3475 pursuant to § 125.12(2)(ag)3., Wis. Stats., and Sheboygan Municipal Code 4-34: The

Committee's findings regarding the activities set forth in Counts 2, 3, and 5 of the Complaint do not constitute a basis for suspension or revocation pursuant § 125.12(2)(ag)2., Wis. Stats., for selling or giving away alcohol to habitual drunkards.

Revocation or Suspension of Amusement License number 3475 pursuant to Sheboygan Municipal Code 6-221: Based upon the Committee's findings regarding Counts 2, 3, and 5 of the Complaint, the Licensee's establishment has become a source of rowdiness in the neighborhood, a source of frequent complaints to police, and a disruption to good peace and order. The Committee recommends a 90-day suspension of Amusement License number 3475.

Count 4 – 10/5/2024 Neighborhood Dispute

The Committee finds the testimony of Officer Jumes to be truthful and accurate. The Committee finds that the neighborhood dispute set forth in Count 4 of the complaint demonstrates a negative effect on the neighborhood, but the effect does not rise to the level of suspension or revocation.

<u>Recommendation</u>

Based upon the Committee's findings of fact and conclusions of law stated above, the Committee recommends that the Common Council of the City of Sheboygan take the following actions:

- Revoke Dancehall License number 3475.
- 2- Suspend Class "B" and "Class B" license number 3475 for a period of 90-days for maintaining a disorderly or riotous house in violation of § 125.12(2)(ag)2., Wis. Stats.

3- Suspend Amusement License number 3475 pursuant to Sheboygan Municipal Code 6-221 for a period of 90-days because the Licensee's establishment has become a source of rowdiness in the neighborhood, a source of frequent complaints to police, and a disruption to good peace and order.

CITY OF SHEBOYGAN CHARTER ORDINANCE 3-25-26

BY ALDERPERSONS DEKKER AND PERRELLA.

SEPTEMBER 8, 2025.

AN ORDINANCE (being subject to the home rule provisions of § 66.0101 of the Wisconsin Statutes) to authorize primary elections whenever three or more candidates file nomination papers for an elective city office.

WHEREAS, the City of Sheboygan has traditionally held primary elections whenever three or more candidates file nomination papers for an elective city office; and

WHEREAS, Wis. Stat. § 8.11(1)(b) permits the common council may avoid the need to annually determine to hold a primary by enacting a charter ordinance providing for a primary whenever three (3) or more candidates file nomination papers for a city office.

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

SECTION 1: <u>ADOPTION</u> Sec. 2-948 of the Municipal Code entitled "Primary Elections" is hereby created so as to read as follows:

"Sec. 2-948 - Spring primary

Whenever three or more candidates file nomination papers for an elective city office, a primary election shall be held for the nomination of candidates for such office."

SECTION 2: REPEALER CLAUSE All ordinances or resolutions or parts thereof in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

CITY OF SHEBOYGAN ORDINANCE 15-25-26

BY ALDERPERSONS RUST AND LA FAVE.

SEPTEMBER 8, 2025.

AN ORDINANCE amending sections of the Sheboygan Municipal Code related to dog kennel licenses and animal fancier permits.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

SECTION 1: <u>AMENDMENT</u> "Sec 8-18 Animal Fancier Permit" of the Sheboygan Municipal Code is hereby *amended* as follows:

AMENDMENT

Sec 8-18 Animal Fancier Permit

- (a) In this section, the term "domestic animal" includes all animals encompassed under the definitions provided in Wis. Stat. §§ 95.001(ad) and 169.01(7).
- (b) No person may keep, harbor, shelter or possess more than three domestic animals including fowl over the age of five months unless the person holds a valid animal fancier permit. There shall be no more than one animal fancier permit issued per dwelling unit.
- (c) The keeping of more than three domestic animals including fowl over the age of five months without an animal fanciers permit is declared to be a nuisance as defined in section 36-1.
- (d) This permit shall be included at no cost with pet licenses issued pursuant to sections 8-9(c) and 8-42. If a person has no pet license because the person owns only animals not requiring licenses, an animal fancier permit shall be issued upon the payment of \$3.00 on an annual basis. The permit year commences on January 1 and ends on the following December 31. The collecting official shall assess and collect a late fee of \$5.00 from every animal fancier applicant if the applicant fails to obtain a permit prior to April 1 of each year, or within 30 days of falling under the requirements of this section. All late fees received or collected shall be paid into the city treasury as city revenue.
- (e) Whenever a humane officer, the director of planning and development or their designee requests an inspection of the interior and exterior premises of a person holding an animal fancier permit or of an applicant for an animal fancier permit, the animal fancier or applicant shall schedule such an inspection and allow the inspection to be completed no later than ten days after the date of the request. A request for a department inspection under this subsection may be made by any of the following

means:

- (1) A written request left at the residence or place of occupation of the applicant or permit holder.
- (2) A written request delivered to a competent adult occupant of the applicant's or permit holder's residence.
- (3) A written request addressed to the applicant or permit holder at the applicant's residence and mailed by first class, prepaid mail.
- (f) Upon the denial of consent to inspect, a humane officer, the director of planning and development, or their designee may apply for an administrative warrant to inspect the premises. A person who fails to comply with an inspection request as required by this subsection may have their permit revoked and may be ineligible for an animal fanciers permit for a period of one year.
- (g) No person who has a criminal conviction for a violation under Wis. Stat. ch. 951 or who has multiple non-criminal convictions for violations under Wis. Stat. ch. 951 or this chapter shall be issued an animal fancier's permit unless the common council or the committee thereof designated for such purposes, upon the request of the person wishing to hold the permit, determines that the issuance of such a permit is in the best interest of the community, that the person wishing to hold the permit is unlikely to reoffend, and that the animals will be properly taken care of. Conditions may be attached to the issuance of a permit in such a situation at the complete discretion of the common council or committee.
- (h) A person holding an animal fancier permit who does not conform to the following requirements shall have their permit revoked and shall be ineligible for an animal fanciers permit for a period of one year. A person who is found not to conform to the requirements below on two or more occasions within a period of five years shall be permanently ineligible for an animal fanciers permit.
 - (1) All animals shall be maintained in a healthy condition or, if ill, shall be given appropriate treatment immediately.
 - (2) The quarters in which the animals are kept shall be maintained in a clean condition and in a good state of repair.
 - (3) Animal pens or enclosures shall be large enough to provide freedom of movement to the animals contained therein and shall be constructed of nonporous and noncorrosive materials.
 - (4) Dogs shall be kept in separate enclosures from cats. Dogs and cats over the age of five months shall be housed in separate enclosures with no more than three dogs or three cats contained within the same enclosure.
 - (5) Food supplies shall be stored in rodent-proof containers and food and water containers shall be kept clean.
 - (6) Litter or bedding material shall be changed as often as necessary to prevent an odor nuisance.
 - (7) Feces shall be removed from yards, pens and enclosures at least daily and stored in tightly covered, secure containers until final disposal.
 - (8) Yards, pens, premises and animals shall be kept free of pest infestations.
 - (9) No odor nuisance shall be permitted. Any animal holding area containing

- animals shall be provided with fresh air by means of windows, doors, vents, exhaust fans or air conditioning so as to minimize drafts, odors and moisture condensation.
- (10) All animals shall have protection from the elements, whether indoors or outdoors.
- (i) The requirement to hold an animal fancier's permit applies to persons operating a commercial animal boarding facility pursuant to section 105-718(j) holding kennel licenses pursuant to section 8-48 and persons operating pet shops, as they are defined in article I of this chapter, except that any person paying the kennel license fee provided in section 8-48 may obtain the animal fancier's permit at no charge.

(Code 1997, § 18-57; Ord. No. 10-03-04, § 1, 7-7-2003; Ord. No. 16-03-04, § 1, 7-21-2003)

SECTION 2: REPEAL "Sec 8-48 Dog Kennel Licenses" of the Sheboygan Municipal Code is hereby *repealed* as follows:

REPEAL

Sec 8-48 Dog Kennel Licenses (Reserved)

- (a) Any person who keeps or operates a kennel in compliance with applicable zoning requirements may, instead of the license tax for each dog required by section 8-42, apply to the collecting official for a kennel license for the keeping or operating of the kennel. Such person shall pay for the license year a license tax of \$55.00 for a kennel of 12 or fewer dogs and an additional \$5.00 for each dog in excess of 12. Upon payment of the required kennel license tax, upon presentation of evidence that all dogs over five months of age are currently immunized against rabies, and upon presentation of evidence that the kennel is in compliance with applicable zoning requirements, the collecting official shall issue the kennel license and a number of tags equal to the number of dogs authorized to be kept in the kennel.
- (b) Kennel license tags shall be made in a form so that they may be readily distinguishable from the individual license tags for the same year. The owner or keeper of a kennel shall keep at all times a kennel license tag attached to the collar of each dog over five months old kept by the owner or keeper under a kennel license, but this requirement does not apply to a dog during competition or training, a dog securely confined indoors, a dog while hunting, or a dog securely confined in a fenced area. These tags may be transferred from one dog to another within the kennel whenever any dog is removed from the kennel. The rabies vaccination tag or substitute tag shall remain attached to the dog for which it is issued at all times, but this requirement does not apply to a dog during competition or training, to a dog while hunting or to a dog securely confined in a fenced area. No dog bearing a kennel tag shall be permitted to stray or to be taken anywhere outside the limits of the kennel unless the dog is on a leash or temporarily out for the purposes of hunting, breeding, trial, training or

competition.

(e) Unless clearly inapplicable, all the provisions of this article relating to the individual dog license tax, licenses and tags shall apply to the kennel license and tags.
