CITY OF SHEBOYGAN ORDINANCE 33-24-25

BY ALDERPERSONS RUST AND LA FAVE.

JANUARY 20, 2025.

AN ORDINANCE amending Section 2-581 of the Sheboygan Municipal Code regarding residency requirements to delete the reference to the Architectural Review Board.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

SECTION 1: <u>AMENDMENT</u> "Sec 2-581 Residency Requirement" of the Sheboygan Municipal Code is hereby *amended* as follows:

AMENDMENT

Sec 2-581 Residency Requirement

- (a) All members of boards or commissions shall be city residents and maintain residency in the city while under the employment or service of the city. In the event that any such member of a board or commission does not meet the foregoing requirement, the office or position shall be automatically forthwith vacated, and such vacancy shall be filled in the manner prescribed by law or ordinance.
- (b) Notwithstanding subsection (a) of this section, the residency requirement shall not apply:
 - (1) To members of a business improvement district board who own or occupy real property in the business improvement district.
 - (2) To nonvoting members of advisory committees to the common council.
 - (3) To licensed members of the board of examiners.
 - (4) To members of the mayor's special international committee residing within the boundaries of the Sheboygan Area School District.
 - (5) To one member of the board of waterworks commissioners who owns real property within and owns or operates a business within the city.
 - (6) To members of the architectural review board established pursuant to section 105-1012 of the city land development code.
- (c) Nothing in this division shall prevent the city administrator from inviting noncity residents to participate as a member of a team of employees or persons with special expertise whose role shall be to advise the city administrator on matters over which the city administrator may make reports or recommendations to the mayor or common council.

(Code 1997, § 2-428)

SECTION 2: REPEALER CLAUSE All ordinances or resolutions or parts thereof in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 3: EFFECTIVE DATE This Ordinance shall take effect after its passage and publication according to law, and as of April 15, 2025.

BACKGROUND / ANALYSIS:

The Quarterly Report of Benchmarks for the Police Department for the period commencing October 1, 2024, and ending December 31, 2024, is presented for information and discussion as required by section 30-50 of the Municipal Code.

STAFF COMMENTS:

Highlights of the report are as follows:

- The increase in crimes against persons continues to be driven by domestic assaults.
- Property crimes remain well below historical levels, with just 42 burglaries in 2024 compared to 65 in 2023.
- There were several large-value burglaries and thefts by fraud that led to an increase in the value of property stolen during 2024. One set of burglaries was responsible for over \$200,000 in stolen property, and one theft by fraud alone accounted for a \$250,000 loss.
- Traffic crashes remained nearly flat year-over-year (1,433 vs. 1,390) due to maintenance of effort with traffic enforcement activities.
- We continue to see a significant reduction in involuntary mental health commitments due to the work of our co-responders.

BACKGROUND / ANALYSIS:

Quarterly Benchmarks from the Fire Department for the period commencing October 1, 2024 and ending December 31, 2024 is presented for information and discussion as required by section 24-459 of the Municipal Code.

STAFF COMMENTS:

Highlights for 2024:

- Call volume reached a record high of 7,078 calls. Over 400 calls higher than previous.
 - Rescue & EMS record high
 - o Non-fire record high
 - Fires dipped to 80 (7 fewer than previous)
 - o 70% of calls run concurrently with another incident
- Inspections
 - Factors contributing to a lower count of completed inspections could include increased call volume impacting time to complete inspections, training time spent adding building pre-plans, and inability to seek out 2nd year violations due to the fire program switch.
- Training hours
 - Reached a high of 17,548 hours. This includes 20 hours per person for estimated time spent pre-planning. All actual training hours may not have been captured due to network outage most of fourth quarter and difficulties administering online training.
