5. Discuss priorities and plan how to best implement pet friendliness at the Council approved parks

The Task Group's recommendations were approved by both the Public Works Committee and Marina, Parks and Forestry Committee on Tuesday, August 9th and received Council approval on Monday, August 15th. The task group has identified seven areas of focus relating to implementation of the recommendations: fencing, signage, waste management, neighborhood relations, education and communications, ordinance management, and success planning. The group will dive into each focus area, identifying a point person/people for each and adding a monthly working meeting to accommodate the process. A group will meet on September 14th to continue planning the rollout. Beginning in October the meeting schedule will add a working meeting on the second Wednesday of the month and continue with the regular task group meetings on the final Wednesday of each month.
