There are presently two "Class A" alcohol beverage licenses available. Kia Yang and Yeng Yang appeared before the committee on behalf of Union Asian Market, 2022 South 17th Street, to present their case regarding pre-application for one of the available

licenses. Union Asian Market is a specialty ethnic grocery store which was established 1982 and they recently took over ownership in January 2022. They carry Asian specific products and want to include alcohol and Asian specific liquors.

8. Presentations by potential applicants for available "Class B" alcohol beverage licenses

There is presently one "Class B" alcohol beverage license available. Maria Pavon, Bailey Kupfer, Nicole Milligan, and Irma Valdez all appeared before the committee to present their cases regarding pre-application for the available license.

Maria Pavon spoke on behalf of Cocina Mi Familia located at 1423 Union Avenue (formerly El Durango). They have owned the business since August 2021 and serve authentic Mexican food. They feel a liquor license would enhance the dining experience. Capacity is presently 80. They are actively renovating and transitioning to the new name. An outdoor dining patio may be added in the future.

Bailey Kupfer spoke on behalf of the Watershed Hotel at 838 North 15th Street on the river. They plan to open on July 1st. This boutique hotel will have 25 rooms and an outdoor event space with a capacity of 200. They estimate 20 to 30 weddings per year during the warmer months. The inside bar has a capacity of 39 and will be open 5-11 p.m. seven days a week.

Nicole Milligan spoke on behalf of Harbor Petroleum, 905 Indiana Avenue. A bar and restaurant will be located on the other side of the gas station. Capacity will be around 50 and they should be ready to open in two to three months. The majority of income will come from the food served which will include Indian food. There will also be gambling machines.

Irma Valdez spoke on behalf of Bar 9 located at 1034 Michigan Avenue. They have been renovating since February 2021 and the bar area is ready, but they need about six more weeks in order to be able to serve food. The bar is primary and the restaurant is secondary. Occupancy is currently 50 and that will increase to 75 when food is served. It will be primarily Mexican food and also bar food.

BACKGROUND / ANALYSIS:

Quarterly Benchmarks from the Fire Department for the period commencing January 1, 2022 and ending March 31, 2022 is presented for information and discussion as required by section 50-564 of the Municipal Code.

STAFF COMMENTS:

Highlights of the First Quarter of 2022 are as follows:

- Total call volume is 245 incidents higher than first quarter of 2021
- Total fire inspections were down for first quarter due to the training schedule; however, inspections are expected to increase compared to the 2021 year-end totals
- Station tour count is expected to rise as COVID restrictions have been lifted
- The goal of achieving a 90% fire response efficiency may become increasingly difficult to achieve as the total department call volume increases. With the increase in call volume, our number of overlapping incidents have also increased. This often requires units to respond from outside of their district
- Resident satisfaction rating will not be indicated in 2022 as the outside firm conducting the community survey did not report a resident satisfaction rating by department.

- Part 1 Crime: There was a decrease in Part 1 crime year to date in comparison to the same period in 2021 and 2020 (156 vs.175 and 185).
- Traffic accidents year to date (342 vs. 340) were relatively flat in comparison to 2021, but a decrease from 360 in 2020.
- There was an increase in involuntary commitments year to date in comparison to the same period in 2021 and 2020 (37 vs. 35 and 19).

Res. No. 3 - 22 - 23. By Alderpersons Felde and Ackley. May 2, 2022.

A RESOLUTION authorizing the appropriate City officials to enter into agreement with the Sheboygan Area School District relative to providing the public school system with school liaison officers from the Sheboygan Police Department.

WHEREAS, it is the mutual desire of the City of Sheboygan and the Sheboygan Area School District to provide the Sheboygan Area Public Schools with liaison officers from the Sheboygan Police Department; and

WHEREAS, the school liaison officer program promotes the public safety and welfare of the City; and

WHEREAS, the City and the school district have agreed to equally finance the cost of the school liaison officer program.

NOW, THEREFORE, BE IT RESOLVED: That the Mayor, City Clerk and Finance Director are hereby authorized and directed to enter into agreement with the Sheboygan Area School District for the provision of school liaison officers from the Sheboygan Police Department to the Sheboygan Area Public Schools for the five-year period from July 1, 2022 through June 30, 2027, in accordance with the terms and conditions of the attached agreement, which is made a part hereof.

AGREEMENT

BETWEEN THE CITY OF SHEBOYGAN

AND

SHEBOYGAN AREA SCHOOL DISTRICT

THIS AGREEMENT, made this ______day of ______, 2022, by and between the City of Sheboygan, hereinafter referred to as the "CITY," and the Sheboygan Area School District, hereinafter referred to as the "DISTRICT."

WHEREAS, it is the mutual desire of the CITY and the DISTRICT to provide the Sheboygan area public high schools and middle schools with five (5) School Liaison officers from the Sheboygan Police Department; and

WHEREAS, the CITY and the DISTRICT have agreed to equally finance the cost of the high school and the middle school liaison program;

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration,

IT IS AGREED AS FOLLOWS:

- 1. The Sheboygan Police Department shall assign, on a full-time basis, a total of five (5) Police Officers to act as school liaison officers as follows:
 - a. One (1) officer to each of the **DISTRICT'S** two (2) public high schools, commencing July 1, 2022.
 - b. Three (3) officers to cover all three (3) of the **DISTRICT'S** public middle schools, commencing July 1, 2022.
- 2. Said department's assigned officers shall continue to maintain their identity as police officers and be answerable as such to their superiors in the department.
- 3. The **CITY** shall budget, be responsible for and pay the remaining fifty percent (50%) of the liaison officers' salaries during the term of this contract, which salaries also shall include, but not be limited to, the Wisconsin Retirement Fund, overtime hours, Social Security, uniform allowance, health insurance, and life insurance payments.
- 4. The **DISTRICT** shall budget, be responsible for and pay the remaining fifty percent (50%) of the liaison officers' salaries during the term of this contract, which salaries also shall include but not be limited to the Wisconsin Retirement Fund, overtime hours, Social Security, uniform allowance, health insurance, and life insurance payments.
- 5. The **DISTRICT** agrees to pay the **CITY** its portion of the SROs' cost as a flat fee to be billed in twelve equal installments. This amount shall be adjusted annually by any actual cost adjustment realized by the **CITY** or the **DISTRICT**. The annual amount to be paid by the **DISTRICT** shall be determined and agreed upon by **CITY** and **DISTRICT** Finance Departments before October 1 of the preceding calendar year.

- 6. The **DISTRICT** shall pay its portion of the liaison officers' salaries at the end of each month and upon receipt of a billing statement from the City Finance Director/Treasurer. Payment received by the **CITY** will be credited back to the Police Department salary account.
- 7. The term of this Agreement shall be five (5) years, commencing the latter of the 1st day of July 2022 or the date executed by the parties, and ending on June 30, 2027.
- 8. Nothing contained herein and agreed to by these parties shall abrogate the **CITY'S** responsibility for keeping in full force and effect such worker's compensation or unemployment compensation insurances for the five (5) assigned liaison officers as required by federal, state or local law.

The City of Sheboygan has had a long-term agreement with The Sheboygan Area School District for the Police Department to provide Liaison Officers to the School District. This agreement has typically been a Five-Year Agreement with the Current Agreement expiring on June 30, 2022. The only change negotiated in the current agreement is for the City to bill the School District a flat monthly fee to simplify the billing process. The annual cost will be calculated by October 1st of the preceding calendar year.
