5. New Fire Department Headquarters update

Chief Montellano gave a brief progress update as the project continues to progress through the council approval process. Architects continue to work on design schematics and the project management team will soon decipher the plan for implementation.

6. Fire contract negotiations update

The Fire Contract is still in process of review by attorney and union officials. Chief Montellano confirmed the contract will be for 5 years (2024 through 2028).

7. Police Department culture update

Chief Zempel shared an update regarding efforts and action toward improving the Police Department's culture. With the help of a consultant, the department has reviewed behavior expectations, mission statement, vision statement, as well as organizational values. The Police Department will be implementing these efforts at fall in service.

The final proposed, edited version will be distributed to the Commission in advance of the October 21st regular meeting so that the Commission is prepared for any applicable action.
