A member who had just passed probation decided to leave the department which has opened up a vacancy. There are two conditional offers of employment out to candidates in the current Firefighter/Paramedic pool.

There may be up to five candidates to interview for the position of Firefighter/Paramedic at the next meeting. Assistant Chief Tuenissen also shared there may be two candidates to be interviewed for the position of Police Officer as well at the November 18th meeting.

11. Police Department promotions

Chief Zempel and Assistant Chief Teunissen recommended the promotion of Jonathon Smith to the position of Detective. Officer Smith is currently a School Resource Officer at Urban Middle School and has been for about 3.5 years. Officer Smith has been with the Sheboygan Police Department for 16 years. Command staff feels he is an up and coming leader and is pleased to present this promotion for the Commission's consideration.
