BACKGROUND / ANALYSIS:

The City of Sheboygan is eligible for funding to support the Sheboygan County Multi-Jurisdictional Enforcement Group through the JAG Drug Task Force Grant Solicitation for calendar year 2023 operations. The City of Sheboygan is eligible to receive funding in the amount of \$24,112 that consists of Federal Justice Assistance Grant funds and state penalty assessment fees. The State penalty assessment funds are State Matching funds and there are no local matching funds required. Funding is aimed at enhancing interagency coordination and intelligence sharing targeting gangs, drugs firearms and associated criminal investigations.

STAFF COMMENTS:

The City of Sheboygan has been the lead agency of the Sheboygan County Multi-Jurisdictional Enforcement Group (MEG Unit) for more than 20 years. The JAG funding is the primary source of outside funding to support this multi-agency effort.
