## 1. New Business

## a. Nuisance Properties

The Nuisance Committee was called to order to discuss and review complaints and issues with posted properties listed below. City Attorney Kalil mentioned that there are seven new properties, two properties new letters can be sent out and three properties have gone through the legal process, City Attorney Kalil stated that if these three properties do not respond after the notice has been sent, the city wins by default. City Attorney Kalil also stated that with the new nuisance statue a court order is not needed to serve these properties, City Attorney Kalil also mentioned that he will start sending out a registered closing letter to the properties who have gone through the legal producers.

City Attorney Kalil stated that he will send out a letter to Aryls and Delasky to start the violation process, Public Works Director Hintz stated that last year he sent a letter to Delasky asking them to fix their sidewalks and the sidewalks are still not fixed and would like for that to be included in the letter that City Attorney Kalil is sending.

Public Works Director Hintz stated that there are three properties where the houses need to be condemned and torn down for health and safety reasons. Brent Coon, Robert Humphries, John Greenall, and Cindy Christensen City Attorney Kalil said he will send a letter to the Richland County Sanitation Office about these properties.

Public Works Director Hintz also mentioned that Alan Amundson and Edgar Keller both own trailer homes that need to be pulled off of the lot and taken to the landfill. Public Works Director Hintz did mentioned that June Decker is trying to purchase these two lots and trailers, and that she

- plans to remove both trailers. Building Inspector Rasmussen mentioned that John Grenell claims he will have his property cleaned up by July 1st, 2023. City Attorney mentioned that he will be sending letters to the other properties to start the violation process.
