Key points discussed at the meeting included the City Manager format would be similar to that of the school districts with the superintendents, the manager's contract could address issues like where they live, mayors wages could offset the cost of the managers wages, the City is a \$15 million dollar business in need of a trained CEO to manage it, not just someone who chose to be elected because they were mad about something.

Also discussed at the meeting was how to get more people involved in the process such as the Chamber emails, around town/events for chamber and newspapers, and radio. Clerk/Treasurer Chamberlin stated she would also like to pitch to the Sunrise Ambassadors teaming up for their December get together, like they did for the growth policy.

Comparison of Forms of Government for Sidney, Montana

Background

Every ten years, Montana cities and towns must place a local government review question on the ballot, giving voters the opportunity to review and, if desired, change their form of government. Currently, Sidney uses a Council–Manager system. Another option often considered is the Mayor–Council system.

Council-Manager Form (Current System)

Pros:

- Professional management by trained administrator.
- Reduces day-to-day politics in operations.
- Clear division: council = policy, manager = administration.
- Typically more consistent budgeting and planning.

Cons:

- Manager is appointed, not directly elected by citizens.
- Can reduce visibility/accountability to the public.
- Council/Manager disagreements can create tension.
- May feel 'less democratic' to some residents.

Mayor-Council Form

Pros:

- Direct citizen accountability: mayor answers to voters.
- Strong political leadership and visibility.
- Better suited for cities that want a more 'hands-on' elected executive.
- Clearer line of responsibility to the public.

Cons:

- Risks of politicizing city operations and staffing.
- Leadership can change abruptly with elections.
- Can reduce professional/technical oversight if mayor lacks management experience.
- Potential for conflict between mayor and council.

Key Considerations for Sidney

Sidney's size and complexity may benefit from professional management, but residents may also value direct accountability. Council—Manager spreads power across the council and manager, while Mayor—Council concentrates executive power in one elected official.

Comparison Table

Executive Leader	Appointed City Manager (professional)	Elected Mayor (political)
Accountability	To City Council	Directly to Voters
Professional Expertise	High (trained administrator)	Varies (depends on election)
Stability	High, less political turnover	Can change with elections
Citizen Input	Indirect (via council)	Direct (via mayor elections)
Risk of Politicization	Lower	Higher

5. Balance of Power and Oversight

Context: City Councils can be elected by wards (geographic areas) or at large (citywide). Representation methods affect accountability and diversity of viewpoints. Currently the City of Sidney has 3 wards, with two Councilmembers representing each ward.

7. Local Powers and Autonomy

Context: Cities in Montana can adopt self-government powers under a charter, which allows more local control over policies, taxation, and regulations (within state limits).

Context: The Review Board is examining whether the current structure provides appropriate checks and balances between branches of local government.
