Mayor Grimm called the regular meeting of the Sandpoint City Council to order at 5:30 p.m. on Wednesday, October 1, 2025, in Council chambers at City Hall, 1123 W. Lake St., Sandpoint, Idaho.

The Mayor then provided an update on departmental projects and activities and introduced attorney Will Herrington, who had been contracted for temporary legal services, effective October 1, 2025, after the City's agreement with Lake City Law had expired on September 30, 2025.

The meeting then proceeded to City Council announcements and reports, at which time a dispute ensued regarding the status of the City's legal counsel, with Councilor Aispuro and Council President Ruehle encouraging Council members to walk out. Councilors Ruehle, Aispuro, Dick, and Schreiber then left the meeting. Immediately following their departure, Councilors Duquette and Howarth then also exited, at which time Mayor Grimm adjourned the meeting at 5:43 p.m.


Executive Session

7. Executive session was not held.


Adjourn
