1. Approval of Minutes from the Committee's April 9, 2026, Meeting - **action item**

Ms. Ellis provided an update on the Downtown Revitalization Phase 3 Advisory Committee's previous meeting. Mr. Peterson then joined the meeting at 11:42 a.m. and also provided a brief update. Information only; no Committee action.

3. Bike Lane and Sharrow Markings on Division

Ms. Ellis gave a brief presentation on the proposed bike lanes and sharrow markings for Phase 2 of the Division Avenue Corridor Improvement Project along N. Division Avenue to obtain Committee input. Following the presentation and discussion, the Committee unanimously

recommended adding a sign to indicate the end of the bike lane, as well as additional bike lane markings on the northbound side of N. Division Avenue.
