1. Committee member Perchynski made a motion to approve the Committee's March 12, 2026, meeting minutes as presented.

2. Update of Downtown Streets Revitalization Phase 3 Advisory Committee - Radley Peterson
 Mr. Peterson stated that there were no new updates on the Phase 3 Downtown Streets Revitalization Advisory Committee.

3. North Boyer Rectangular Rapid Flashing Beacon - Relocation
 Mr. Brubaker presented information regarding the proposed relocation of a Rectangular Rapid Flashing Beacon (RRFB) on North Boyer Avenue. Following brief discussion, Committee Member Heller moved to relocate the RRFB to the sidewalk break on the west side of North Boyer Avenue. The motion included direction for Public Works to field-fit the final location at their discretion, approximately 300 feet north of the existing crossing. Committee member Lankamer

seconded the motion, and the motion was passed unanimously by Committee members present.
