- 2. **AB25-004**: Interlocal Agreement for Fire Garage Consortium. This item was introduced by Chief Bailey who noted the Fire Garage is a service done out of South County for repair of fire apparatus and EMS units. Snoqualmie has been a member since 2020 and the proposed changes are related to language cleanup and not financial. Committee questions followed. This item is approved to move forward at the January 13, 2025, City Council meeting on the consent agenda.
- 3. **AB24-120**: Interlocal Agreement Renewal with King County for Jail Services. This item was introduced by Chief Lynch who noted this was brought forward at a prior committee meeting and was held pending King County's approval which occurred in December 2024. This item is approved to move forward at the January 13, 2025, City Council meeting on the consent agenda.
- 4. **AB25-002**: Amendment to the 2019 North Bend Interlocal Agreement for Police Services. This item was removed from the agenda.
- 5. **AB25-005**: Snoqualmie Fire Department 2025-2030 Strategic Plan. This item was introduced by Chief Bailey who reviewed highlights of the strategic plan and next steps. Discussion regarding implementation and committee questions followed. This item is approved to move forward at the January 13, 2025, City Council meeting on the non-consent agenda.
