#### **CALL TO ORDER & ROLL CALL**

- 2. Echo Glen Update. Chief Lynch introduced Dan White, Superintendent of Echo Glen Children's Center, who provided handouts and spoke to security measures and progress of installation and the architect rendering of the perimeter fence at Echo Glen. He also spoke to additional security measures which have been implemented and other ways to make the facility safer. Committee comments followed.
- 3. Standards of Cover/Community Risk Assessment Update provided by Chief Bailey who indicated there may be some minor changes with gap analysis and his recommendation is that is it doesn't need to be changed at this point but 2024 numbers can be added in January or February. The Department is waiting for the Commission hearing on August 5, 2024. Committee comments followed.
- 4. Railroad Avenue Fire Update. Presentation provided by Captain Fouts. Topics included the after-action report for commercial structure fire at 8103 Falls Ave SE, incident detail, impact to the city and the four businesses, total risked property and total saved property, effective response force, accreditation and compliance, and investigation and building facts. Discussion followed.
- 5. North Bend Police Services Contract Discussion. Presentation provided by City Administrator Mike Chambless. Topics included current agreement for police services, automatic renewal, termination, prenegotiated renewal terms, North Bend status/request, analysis, and potential counter.
