12. Mayor's Report:

- CM Wotton and Mayor Ross presented at the WSDOT meeting regarding the jurisdictional transfer of Snoqualmie Parkway. Additional information will be forthcoming. The next meeting will be in October when they will issue final determination. If approved, it will go to the next legislative session.
- Snoqualmie Valley Transportation, Mt. Si. Senior Center, and the cities of North Bend and Snoqualmie were awarded Puget Sound Regional Council's Vision 2050 Award in the category of Working Together.
- The cities of Snoqualmie and Duvall entered into a settlement agreement effective July 18, 2023.
- Northwest Railway Museum hosted "Day Out with Thomas" train for nine days all tickets were sold out and the downtown businesses were busy. We thank Northwest Railway for hosting this event.
- Chat with Councilmembers will occur this coming Thursday at Snoqualmie Community Park from 5-6:30 pm before Music in the Park which begins at 6:30 pm.
- Snoqualmie Police Department's National Night Out is August 1, 2023, from 4-8pm.
- The Shop, Ship, Support Snoqualmie marketing campaign encourages residents to shop locally to avoid traffic congestion, save time, and support local businesses. Kudos to city staff and chamber of commerce on this campaign. Brief discussion regarding parking in the downtown area.

Executive session pursuant to RCW 42.30.110(1)(a)(i) To discuss with legal counsel representing the agency matters relating to agency enforcement actions, or to discuss with legal counsel representing the agency litigation or potential litigation to which the agency, the governing body, or a member acting in an official capacity is, or is likely to become, a party, when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence to the agency lasting approximately 5 minutes.

Executive session pursuant to RCW 42.30.110(1)(a)(i) To discuss with legal counsel representing the agency matters relating to agency enforcement actions, or to discuss with legal counsel representing the agency litigation or potential litigation to which the agency, the governing body, or a member acting in an official capacity is, or is likely to become, a party, when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence to the agency lasting approximately 20 minutes.

Executive session pursuant to RCW 42.30.110(1)(a)(i) To discuss with legal counsel representing the agency matters relating to agency enforcement actions, or to discuss with legal counsel representing the agency litigation or potential litigation to which the agency, the governing body, or a member acting in an official capacity is, or is likely to become, a party, when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence to the agency lasting approximately 10 minutes.

Executive session pursuant to RCW 42.30.110(1)(c) To consider the minimum price at which real estate will be offered for sale or lease when public knowledge regarding such consideration would cause a likelihood of decreased price. However, final action selling or leasing public property shall be taken in a meeting open to the public lasting approximately 15 minutes.

Mayor Ross stated no action would occur following Executive Session. Council will adjourn directly from the Executive Session, which was expected to end at 9:30 pm, and not return to open session.

Executive Session commenced at 8:43 pm.

At 9:34 pm, Executive Session ended. It was moved by CM Holloway, seconded by CM Washington to adjourn the meeting. The meeting adjourned at 9:34 pm.
