- The Community Development team continues to work to zone Snoqualmie Ridge and revise the Comprehensive Plan.
- Economic Development Coordinator – interviews have been conducted and a selection decision is pending.
- Senior Planner – position will be advertised in August after the Economic Development Coordinator is hired.
- Legal Assistant – position has been advertised and closes mid-August.

No executive session was held.

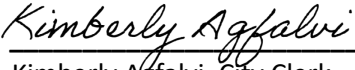
**ADJOURNMENT.**
