## JANUARY 26, 2026

- Jesse Skorupa of Snoqualmie spoke on behalf of Snoqualmie Valley Indivisible. He thanked the City for their public safety and community trust. He asked the City to proactively evaluate its policies and preparedness if ICE activity increases in the Snoqualmie Valley.
- Cristie Coffing of Snoqualmie spoke on immigration and federal law, along with wanting to know the administration's statement in response to ICE.
- Jen Good of Snoqualmie spoke on the need for City Council to have a policy and procedure ready for when ICE comes.
- Debra Landers of North Bend spoke on representing North Bend Art and Industry, along with the Snoqualmie Valley Center for Creativity. She discussed the new programs for 2026.
- Andre Testman of Snoqualmie spoke on ICE recommendations and the City being prepared for when ICE comes. He hopes and requests that the City disclose flock technology, and the City state its commitment to protecting the constitutional rights of all its residents.
- Mike Z. of Snoqualmie thanked the City Council for the job they do. He spoke on the City's need for a public statement on ICE, that is thoughtful and firm.
- Karen Rocco of unincorporated King County spoke on the impact that ICE has on students.

**Authorize the Mayor to sign the proposed amended agreement allowing the City of Seattle to join King County -IFIT**

**Community Development Committee:** There was no report.

**Parks & Public Works Committee:** There was no report.

**Finance & Administration Committee:**

8. **Discussion:** Flood Recovery and Financial Update – Director Bouta led the discussion. He spoke on how the flood will impact the City’s Reserve Fund. Director Bouta further discussed how the Reserve Fund works. Councilmembers and the Mayor joined the discussion to provide insight and ask questions.

**Committee of the Whole:**

9. Legislative Priorities. CM Johnson led the discussion. He made recommendations for edits to the document. Councilmembers discussed changes they would like to see made to the document.

**Strike “and some property crimes” from the Legislative Priorities document.**

FAILED: 3-4 (Murphy, Aye; Wotton, Nay; Holloway, Nay; Washington, Aye; Cotton, Nay; Christensen, Nay; Johnson, Aye)

It was moved by CM Christensen; seconded by CM Holloway to:

**Strike “King County has proposed cutting funding to the Crisis Intervention Training program at the police academy by 75%. This will reduce the number of classes available from 12 per year to only 3, which will only accommodate 90 students per year.”**

PASSED: 7-0 (Murphy, Wotton, Holloway, Washington, Cotton, Christensen, Johnson)
