## **REPORTS**

#### 18. Mayor's Report:

- Great job to parks and public works, police, fire, communications, and all the city staff during the
  recent storms. She provided a review of winter storm statistics including power outages, road
  conditions, frozen pipes, tree related incidents, traffic hazard collisions, and emergency public notices.
- A letter from seven local mayors has been sent to the House and Senate Transportation Committees regarding opposition to the SR18 delay.
- Council's signed King County Metro letter requesting services across SR18 has been sent.
- Council's Legislative Priorities were finalized in December 2022 and councilmembers are encouraged to reach out to legislators regarding those.
- Councilmembers were encouraged to respond to the pending survey to identify stakeholders to form a community center expansion steering committee. The survey closes on Friday.

 Today is Law Enforcement Appreciation Day and she thanked the police officers for their hard work, dedication, and for keeping our community safe.

# 19. Commission/Committee Liaison Reports.

- Councilmember Wotton: The Mayor will be speaking on behalf of CLTC in Olympia. The Governor's proposed budget delays SR18 for several years well beyond 2029. The ILA with Meadowbrook Farm is under way and there has been a few meetings between North Bend and Snoqualmie, and eventually the tribe, to work on getting that formalized. For affordable housing, we have been working with other cities, particularly North Bend and Carnation, to look at a proposed timeline and are looking at reporting back to council in late February or early March. He has been appointed to the regional Law Safety and Justice Committee.
- Councilmember Christensen She was on the advisory council for the King Conservation District as an alternate. She has since applied and was put on as a member. Last week she attended the SCA lunch and learn on behavioral health which addressed the King County Crisis Care Center levy which is proposing to add additional crisis care centers in King County. The levy is proposed to be on the ballot in April.
