- Art Off The Rails: Publicity is currently ongoing. 425 Magazine will run an article on the festival. Additionally, Nicole Wiebe has contracted for paid advertising in June. The webpage is ready. The three non-profit partners, NWTM, Historic Downtown Merchant's, and North Bend Art and Industry, have applied for a WA ST Tourism grant. Musicians are currently being booked.
- Creative District: Annette Roth presented to the Economic Development Commission in March. The Creative District is not accepting applications in 2024. Various potential stakeholders in the Snoqualmie community are in the gathering stage of information.
- Art Classes: Commissioner Miller and Nicole Wiebe, met with KCLS Snoqualmie Library librarian about a mutual interest in providing adult art classes in September. A second class geared towards teens TBD for November.
- Council Liaison Cotton reported that she serves on the Snoqualmie Days Committee, and the Chalk the Block, will be an element at the Fire Station Pancake Breakfast. Commissioner Cronk will assist at the breakfast.

- Nicole Wiebe discussed an Open Mic at Movies in the park. More to come potentially.
- Commissioner Miller asked commissioners to discuss and consider a juried art show in 2025.
- Nicole Wiebe discussed a Call for Artists, for a new pole banner theme.
