Subject: Economic Development Element

At the May 17, 2023 Economic Development Commission (EDC) meeting, staff presented draft goals and policies for the upcoming update of the Economic Development element of the Comprehensive Plan. This presentation focused on policies related to Business Retention and Recruitment and Business Climate, on which staff received feedback and direction from Commissioners.

On June 21, 2023, staff will present revisions of the draft policies based on Commissioners' feedback, some contextual economic data that will help inform the discussions, as well as new policies related to Planning and Investment and Enhancing and Leveraging Community Assets. Staff plan to return in July to complete the EDC's review of these policies and finalize a recommendation that will be transmitted to the Planning Commission.

#### **Business Retention and Recruitment**

Goal: The City supports the continued success of local businesses and recruits businesses that meet the retail needs of residents, offer diverse employment opportunities, enrich the City's unique character, and generate revenue to support City services.
