MINUTES

1. The minutes of August 15, 2022 were approved.

AGENDA BILLS

2. AB22-116: South Correctional Entity (SCORE) Interlocal Housing Agreement Annual agreement that Snoqualmie PD uses to book inmates. Rates are increasing, did not increase last year but instituted at \$35 booking fee, increasing this year to \$50. Nightly bed rate increasing from \$189 to \$199 per inmate. SCORE takes inmates that have medical issues.

3. AB22-130: Allocation Agreement, Memoranda of Understanding (MOU) and Participation Form approving distribution of settlement funds to local governments from WA Attorney General Opioid Litigation." This agenda bill # will be amended to # 22-118. If Council approves, this allows the City to share in the litigation funds of \$125 – \$140k over 17 years. The first payment will begin in December if council approves. The MOU also provides for individual distributions.
