This meeting was conducted in person at Snoqualmie City Hall and remotely using Zoom.

CALL TO ORDER & ROLL CALL - Chair Rob Wotton called the meeting to order at 5:01 pm.

PUBLIC COMMENTS

- Ethan Benson, Snoqualmie, commented on the incident in New Orleans on Bourbon Street and how that may relate to Snoqualmie's King Street closure. He also commented on the California wildfires and inquired into how wildfires could affect Snoqualmie.

AGENDA BILLS

- AB25-002:** Amendment to the 2019 North Bend Interlocal Agreement for Police Services. This item was introduced by City Administrator Chambless. Committee comments followed. Public comment was received by North Bend Mayor Mary Miller and Mayor Pro Tem/Councilmember Mark Joselyn who expressed their support for building a strong and positive relationship between the two cities. Chief Lynch thanked the North Bend representatives for speaking and being present tonight. Additional committee comments followed. Mayor Ross thanked North Bend for being present this evening and for their comments.
