- **Council Presentation:** Arts Commission to prepare a summary of 2023 for 11/13/23 City Council Meeting. Commission to attend council meeting, if schedule allows.
- **Murals:** City Attorney working on policy for RFQ for building murals.
- **Selfie Murals:** Continue “Larry the Elk” murals and possible add “Elke the Elk” murals.
- **Commission Member Status:** Accepting applications for one opening and potential for second.
