CALL TO ORDER – Chair Cotton called the meeting to order at 5:01 pm.

Committee Members: Councilmembers Daniel Murphy and Cara Christensen (Remote) were present.

Mayor James Mayhew was also present.

AGENDA APPROVAL – The agenda was approved as presented.

PUBLIC COMMENTS – Ethan Benson made public comment about the City's flood response. Mr. Benson thanked city staff. He spent time thanking the Parks & Public Works Department for the support they provided.

2. **AB25-126:** 2026-2031 Parks Property Tax Levy Agreement - Finance Director Bouta lead the discussion. Councilmembers joined the discussion and asked questions. CID Manger Gamble joined the conversation to provide further insight to the Committee. Mayor Mayhew joined the discussion and asked Director Bouta questions regarding the Tax Levy Agreement. 3. Update on Downtown Sewer Repairs – Parks and Public Works Director Hamlin Discussed how he would like to get the Committee up to speed on complex projects the department is currently going on. Director Hamlin gave a presentation on the December 2025 Flood Damage. He provided information on two sinkholes that formed in the city during the flood event. Councilmember Cotton joined the discussion and asked questions. CM Murphy asked questions for the director. Mayor Mayhew joined the discussion to provide additional information to the Committee.
4. Briefing on 2026 CIP Project Schedule – CIP Manager Dylan Gamble discussed the Project Schedule and the difference between a City Project and Program. CIP Manager Gamble presented to the Committee the "City of Snoqualmie: DRAFT 2026 Capital Improvement Plan." Councilmembers joined the discussion along with Director Hamlin.
