- **3.** AB22-076: 2023-2024 Biennial Budget Budget Manager Drew Bouta discussed the proposed budget. Captain Lynch briefed the Committee on recent conversation with North Bend on the (Police) Take Home Vehicle program included in the budget, the current North Bend Police Contract, and the challenges that would be faced if one City implemented the Program and the other did not.

- **4.** Comprehensive Emergency Management Plan (CEMP) update: Fire Chief Mark Correira explained the CEMP needs to be approved by Council at least every five years. The plan is due for approval later this year, but it is a very lengthy document. Chief Correira will share portions of the document in the coming weeks giving the Committee time to review it before approval. An extension can be requested from the State if more review time is needed.
- **5.** Wildfire Risk to the Community: Deputy Chief Mike Bailey gave an update on the Loch Katrine Fire located 12 miles north of the City. Fire Chief Mark Correira discussed online resources available to the Committee and Community to

keep them informed on wildfires in the area. Chief Correira also briefed the Committee on wildfire risk planning for 2023.

SUMMARY

INTRODUCTION

Section 10.08.010 of the Snoqualmie Municipal Code prohibits parking a vehicle on the street for longer than 24 hours. This Ordinance clarifies the Code by requiring that a vehicle must be moved to a different block every 24 hours.

ORDINANCE NO 1271

AN ORDINANCE OF THE CITY OF SNOQUALMIE, WASHINGTON AMENDING SECTION 10.08.010 OF THE SNOQUALMIE MUNICIPAL CODE

WHEREAS, Section 10.08.010 regulates parking on public streets, alleys, parking strips, sidewalks and pedestrian lanes of the City for a continuous period longer than 24 hours; and

WHEREAS, the City has been made aware of persons parking vehicles for extended periods of time within the same block; and

WHEREAS, the City Council desires to amend existing parking regulations in order to eliminate parking for longer than 24 hours within the same block;

WHEREAS, the City council finds that this ordinance benefits the health, safety and welfare of the residents of the City;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Snoqualmie, Washington, as follows:

<u>Section 1</u>. Section 10.08.010 of the Snoqualmie Municipal Code is hereby amended to read as follows:

10.08.010 Parking for 24 hours.

A. No person shall park any automobile, truck, motorcycle or trailer upon any public street, alley, parking strip, sidewalk or regularly established pedestrian lane of the city for a continuous period longer than 24 hours. A vehicle shall be deemed to be parked in violation of this section unless the vehicle is moved to a different block every 24 hours. For purposes of this section, a block is defined as the stretch of roadway between the two closest public street intersections on either end of the stretch. Where a roadway ends, a block is defined as the stretch of roadway between the end of the roadway and the closest public street intersection.

B. In addition to the civil penalty imposed by this chapter, any vehicle parked in violation of this section shall be subject to impoundment as provided in SMC 10.20.050. (Ord. 935 § 2, 2003; Ord. 714 § 1, 1993; Ord. 397 § 2, 1973; Ord. 246 § 2, 1948).

<u>Section 2</u>. <u>Effective Date</u>. This ordinance shall be effective 5 days after passage and publication, as provided by law.

<u>Section 3</u>. <u>Severability</u>. If any one or more section, subsection or sentence of this ordinance is held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portion of this ordinance or the Snoqualmie Municipal Code sections, and the same shall remain in full force and effect.

Section 4. Corrections by City Clerk or code Reviser. Upon approval of the City Attorney, the City Clerk, and either the Community Development Department Director or the Parks and Public Works Department Director, as applicable, code revisers are authorized to make necessary corrections to this ordinance and Snoqualmie Municipal Code sections, including the correction of clerical errors; references to other local, state or federal laws, codes, rules or regulations; or ordinance or Snoqualmie Municipal Code section numbering and section/subsection numbering.
