PUBLIC SAFETY COMMITTEE REGULAR HYBRID MEETING MINUTES February 20, 2024

CALL TO ORDER & ROLL CALL

Chair Wotton called the meeting to order at 5:00 pm.

Committee Members: Councilmembers Rob Wotton, Cara Christensen, and Catherine Cotton.

AGENDA APPROVAL: The agenda was approved as amended. Chair Wotton added a brief discussion of Committee Priorities to the end of the agenda.

PUBLIC COMMENTS: There were no public comments.

MINUTES

1. The minutes dated January 16, 2024, and February 5, 2024, were approved as presented.

2. Fire 4th Quarter 2023 Accreditation Report. Fire Chief Mike Bailey introduced this item and spoke to the status of the accreditation process. Topics covered included the workplan, incidents, performance measures, fire inspections, and property loss/saved. Discussion followed.
3. North Bend Update. Police Chief Brian Lynch provided an update on 2024 police responses within North Bend. Discussion followed.
4. Chat with the Chiefs Update. CM Christensen introduced this item. Chief Lynch noted it was well attended and positive. Citizen concerns were expressed about crimes, property, and speed. Chief Bailey added citizens were concerned about their voice not being heard, staffing, and funding. Committee comments followed.
