## SUMMARY

## INTRODUCTION

The purpose of this agenda bill is to obtain authorization to purchase replacement vehicles and equipment for the 2025-26 Biennium. Due to manufacturer lead times, new order delivery delays, manufacturer model year retooling/rebidding, early authorization is requested to utilize the full 24-month timeframe to complete orders. Council authorization is required as the purchase of the individual (each) listed assets exceeding \$50,000.00.

## BACKGROUND

The Equipment Replacement and Repair (ER&R) Fund was established in 2005 to set aside funds annually for the replacement of vehicles or equipment as they reach the end of their useful lives. Once a vehicle is due for replacement, and with Council approval, the City draws upon the accumulated funds to pay for the replacement without any additional borrowing or interfund transfers.

## ANALYSIS

Administration is recommending the purchase of twenty-three (23) existing ER&R vehicles and equipment for the 2025-26 Biennium. New, Contracted, or Added assets for the 2025-26 Biennium will be brought forward in the future for approval to include division-specific justification.

## **BUDGET IMPACTS**

Administration recommends approving the purchase of 23 vehicle and equipment replacements for approximately \$3,154,741, which includes \$124,625 in contingency funds. For the 2025-2026 biennium, the City budgeted \$3,462,449 within the ER&R Fund (#501) to purchase replacement vehicles and equipment. Currently, nothing has been spent or encumbered. Therefore, sufficient appropriation exists within the ER&R Fund (#501) to fund the purchase.

## **NEXT STEPS**

Following council approval, staff will continue forward working with divisions for updated department needs. Purchasing state contract vehicles and equipment.

## **PROPOSED ACTION**

Move to approve the purchase of twenty-three (23) Vehicles and Equipment Replacements for the 2025-26 Biennium.

## INTRODUCTION

The purpose of this agenda bill is to obtain authorization to surplus replacement vehicles and equipment for the 2025-26 Biennium.

## BACKGROUND

The Equipment Replacement and Repair (ER&R) Fund was established in 2005 to set aside funds annually for the replacement of vehicles or equipment as they reach the end of their useful lives. Once a vehicle is due for replacement, and with Council approval, the City draws upon the accumulated funds to pay for the replacement without any additional borrowing or interfund transfers. Equipment viable enough to be surplused is sold at auction. Money produced in the surplus sale or auction process it placed back into the ER&R fund.

## ANALYSIS

Administration is recommending the surplus of thirty-three (33) existing ER&R vehicles and equipment for the 2025-26 Biennium.

## **BUDGET IMPACTS**

No budgetary impact.

## **NEXT STEPS**

Following council approval, staff will continue forward removing reusable equipment, removing all city markings, title /licensing, bill of sales, and prep asset for sale. Working with auction vendor Govdeals.com to place vehicles and equipment for sale on online website. Post auction, working with transport staff, sale paperwork, and scheduling new owner pick up, transport. All sales moneys are handled through the Auction vendor and sent by check to our finance to be placed back into the ER&R fund.

## SUMMARY

## INTRODUCTION

In accordance with Snoqualmie Municipal Code <u>2.48.050(</u>A)(2), Resolution No. 1702 ratifies the Proclamation of Emergency dated November 20, 2024.

## BACKGROUND

A severe windstorm struck the city of Snoqualmie beginning on November 19, 2024, with wind gusts exceeding 50 mph. Parks & Public Works crews, as well as several contractors, responded to the storm working around the clock to clear roads of fallen trees, and maintain the functionality of water and wastewater systems during communications and power failures. Over 100 street and park trees were lost in the storm, and storm cleanup and restoration of streetscapes is ongoing.

Snoqualmie Municipal Code 2.48.050(A)(2) authorizes the Mayor to take all necessary actions and measures to combat a disaster; protect persons, property, and natural resources; and provide emergency assistance to victims of the disaster and exercise powers authorized in <u>RCW 38.52.070</u>. The Proclamation of Emergency authorizes each city department or office the ability to: (1) Enter into contracts for services and mutual aid agreements, rent equipment, purchase supplies and materials, and incur obligations on behalf of the City as necessary to respond to and/or combat the severe winter conditions and related emergency conditions, to

protect the health and safety of persons and property; (2) Close or restrict access to, and evacuate, such roads, streets or other areas of the City as may be adversely affected by the emergency; (3) Provide appropriate emergency assistance to the victims of the emergency; and (4) Other, as determined appropriate by the Mayor, City Administrator or Department Heads, as applicable.

## **BUDGET IMPACTS**

Budget impacts, if any, are unknown at this time.

## **RECOMMENDED ACTION**

MOVE to approve Resolution No. 1702 ratifying Proclamation of Emergency 24-23.

## **RESOLUTION NO. 1702**

## A RESOLUTION OF THE CITY OF SNOQUALMIE, WASHINGTON, RATIFYING THE NOVEMBER 20, 2024, PROCLAMATION OF EMERGENCY.

WHEREAS, it was reported to the Office of the Mayor, that beginning November 19, 2024, severe winds, later known as a bomb cyclone, were expected to affect the City of Snoqualmie;

WHEREAS, Section 2.48.020(B) of the Snoqualmie Municipal Code defines an "emergency" as including "an event or set of circumstances which demands immediate action to preserve public health, protect life, protect property, protect natural resources or to provide relief to any stricken community overtaken by such occurrences"; and

**WHEREAS**, SMC 2.48.050(A)(2) authorizes the Mayor to, among other things, "[i]ssue and transmit to federal, state, regional and local agencies a proclamation of local emergency authorizing the mayor and city staff to, *inter alia*, take all necessary actions and measures to combat a disaster; protect persons, property, and natural resources; and provide emergency assistance to victims of the disaster and exercise powers authorized in RCW 38.52.070; and

WHEREAS, on November 20, 2024, Mayor Katherine Ross issued Emergency Proclamation 24-23 authorizing each city department or office the ability to:

(1) Enter into contracts for services and mutual aid agreements, rent equipment, purchase supplies and materials, and incur obligations on behalf of the City as necessary to respond to and/or combat the severe winter conditions and related emergency conditions, to protect the health and safety of persons and property; (2) Close or restrict access to, and evacuate, such roads, streets or other areas of theCity as may be adversely affected by the emergency;

(3) Provide appropriate emergency assistance to the victims of the emergency; and

(4) Other, as determined appropriate by the Mayor, City Administrator or Department Heads, as applicable; and

**WHEREAS**, SMC Section 2.48.050(A)(2) provides that "following its issuance, such a proclamation [of emergency] must be approved by the City Council when practical";

**NOW, THEREFORE, BE IT HEREBY RESOLVED** by the City Council of the City of Snoqualmie, Washington hereby ratifies the Proclamation of Emergency issued on November 20, 2024, attached hereto as Exhibit A, and all emergency actions taken by the City under the authority thereof.

# CITY OF SNOQUALMIE, WASHINGTON

## PROCLAMATION OF EMERGENCY

WHEREAS, a severe windstorm storm struck the City of Snoqualmie beginning on November 19, 2024, and has caused disruption of services, resulted in power outages, affected roadways, and created hazardous driving conditions, in the City of Snoqualmie; and

WHEREAS, this has caused a threat to life, property, and the ability to provide public safety; and

WHEREAS, this constitutes an emergency as defined by the Snoqualmie Comprehensive Emergency Services and Management Plan, and necessitates the utilization of emergency powers granted pursuant Snoqualmie Municipal Code Chapter 2.48 and RCW 35.33.081(2);

**NOW, THEREFORE, BE IT HEREBY PROCLAIMED** by the Mayor of the City of Snoqualmie that an emergency exists in Snoqualmie, and in order to respond to said emergency, and to protect the public health, safety, order and welfare within the City of Snoqualmie, the following actions are authorized:

The Mayor, City Administrator, and each City of Snoqualmie department or office is authorized to exercise the powers vested under this Proclamation of Emergency, including, but not limited to, the following:

(1) Enter into contracts for services and mutual aid agreements, rent equipment, purchase supplies and materials, and incur obligations on behalf of the City as necessary to respond to and/or combat the severe winter conditions and related emergency conditions, to protect the health and safety of persons and property;

(2) Close or restrict access to, and evacuate, such roads, streets or other areas of the City as may be adversely affected by the emergency;

(3) Provide appropriate emergency assistance to the victims of the emergency; and

(4) Other, as determined appropriate by the Mayor, City Administrator or Department Heads, as applicable.

The foregoing actions and exercise of emergency powers may be undertaken without regard to time consuming procedure and the formalities prescribed by law (excepting mandatory constitutional requirements), such as budget law limitations, requirements of competitive bidding and publication of notices, provisions pertaining to the performance of public work, entering into contracts, the incurring of obligations, the employment of temporary workers, the appropriation and expenditures of public funds, and/or provisions relating to collective bargaining.

It is the policy of City of Snoqualmie that no guarantee is implied by actions authorized above, and that there is no perfect emergency response system. In any given set of circumstances, the City of Snoqualmie, its officers, employees and agents, and its assets and systems may be overwhelmed, and the City can only endeavor to make every reasonable effort to respond based on the situation, and information and resources available at this time.

The emergency declared herein shall be in place immediately upon the date of adoption and continue and shall remain in place until terminated, extended, or amended by further Proclamation of the Mayor and/or action of the City Council.
