The meeting was called to order at 2:05 pm. In attendance were Commissioner Chair Jennifer Bragg, Commissioner Grahame Ross, Budget Manager Drew Bouta, and City Clerk Deana Dean (staff liaison).

MINUTES

2. Continued discussion on salaries and benefits for Snoqualmie elected officials. Chair Bragg noted she agrees with what the commission has come up with so far including all-in numbers, COLA, and eliminating the FTE designation. Commissioner Ross noted the most important thing in the data set was to include cities with a strong mayor form of government and to make the decision overall fair and current. Discussion regarding salaries, benefits, COLA, and FTE designation. Budget Manager Drew Bouta provided information on options for calculating COLA and amounts paid by the city for employee health insurance. Discussion followed.
