A. Welcome, Roll Call, and Introduction: By Mayor Dawn R. Ramsey

Mayor Ramsey welcomed everyone present and introduced the meeting.

B. Invocation: By Council Member Brad Marlor

Council Member Marlor offered the invocation.

C. Mayor and Council Coordination

Council Members discussed the upcoming November 8 strategic planning meeting.

Mayor Ramsey discussed the Wasatch Choice Vision Meeting yesterday and the Compensation Committee Meeting this morning.

D. Discussion/Review of Regular Council Meeting

The Mayor and Council briefly reviewed the agenda for the City Council Meeting.

E. Presentation Item

E.1. Park and Recreation Draft Master Plan. (*By Associate Director of Parks, Colby Hill*)

Associate Director of Parks Colby Hill introduced the consultants and Kyrene Gibbs.

Kyrene Gibbs reviewed Attachment A, the Y2 Analytics Survey results. She noted that Summerfest was unfortunately not included in this survey.

Council Member Zander noted that the Council District maps might have been outdated and Ms. Gibbs responded that she would check that and update the results accordingly.

Madison Merrill reviewed Attachment B, Preliminary Park Analysis. It was noted that Daybreak Parks were not included in calculations since those are private parks, and council members noted that there should be a disclaimer of sorts that this analysis doesn't include those Daybreak amenities. She also noted that projections in this analysis do not include annexed land dedicated for parks or other future park land.

Mayor Ramsey asked why only some of our schools are listed in the presentation.

Council and presenters discussed some of the underserved areas on the maps and options.

Ms. Merrill asked, in terms of level of service, where the city would like to see changes and what their thoughts were.

Mayor Ramsey responded that Bingham Creek Regional Park will help with those service numbers significantly in the future.

The council and staff discussed that future park areas will also help to keep those levels of service at a good level as new areas of the city are added and planned out. They also discussed the responses on possible additional fees for parks and improvements.

Council Member Zander noted that when surveyed, the residents in the newly annexed areas were more interested in parks and trails, followed by sports courts and then sports fields. She asked staff to review those slides and take that into consideration if she interpreted it correctly.

F.1. Senior Advisory Committee member appointment. (*By Director of Recreation, Janell Payne*)

Director of Recreation Janell Payne and Community Center Manager Jamie Culbertson introduced new applicant, Carrie Jansky.

Carrie Jansky briefly introduced herself. She moved here from Indiana when her children were young. She is interested in this position because she has noticed how the elderly are being treated, and it's very discouraging to her.

Council Member Marlor motioned to recess the City Council Study Meeting and move to Executive Closed Session. Motion was seconded by Council Member Shelton; vote was unanimous in favor.

PARKS & RECREATION MASTER PLAN SURVEY 2023 PUBLIC OPINION RESEARCH





- 1. Overall use of South Jordan recreational amenities is high, with 52% of residents using South Jordan parks and 41% using trails at least a few times a month or more. Residents prefer parks and trails that are close to home.
- 2. While the majority of city residents are satisfied with the number of parks in the city, there is a significant portion who say there are not enough trails (46%) or recreation opportunities (35%), indicating that those might be good areas of focus for the City.
- 3. In terms of improvements that residents would make to parks and trails, residents express the most interest in shade structures, trees/landscaping, more restrooms, overall maintenance/cleanliness, and pet waste disposal stations.
- 4. Of those that participated in a South Jordan-sponsored community event, the South Jordan Farmer's Market is by far the most popular. Live music/community concerts is a potential activity that would entice residents to visit City parks more often.
- 5. When it comes to funding special use facilities, South Jordan residents prefer pickleball courts, outdoor amphitheater, dog park, and all-abilities park. Residents also prefer to allocate funding to existing parks/playgrounds and walking/biking trails. The majority of residents (51%) oppose the idea of a "Park Fee" for City parks.

THINGS TO REMEMBER

SURVEY METHODOLOGY



428 residents in South Jordan City were sampled from a city utilities list and supplemental registered voter list. Invitations to participate in the online survey were sent via email and text message.



Online survey interviews were collected from September 20th through October 12th, 2023.



Margin of error ± 4.7 percentage points.




Respondents are geographically representative of South Jordan City residents at large. The sample has been weighted by age, gender, race, and city council district based on population estimates from the United States Census Bureau.

We have significant representation in each of South Jordan's five City Council districts with roughly 50-100 panelists residing in each district.




GENERAL SATISFACTION AND ATTITUDES

CLEAN NEIGHBORHOODS AND REC OPPORTUNITIES HIGH PRIORITIES

On average, South Jordan residents rate their quality of life as high (84 out of 100). Residents prioritize clean neighborhoods and recreation opportunities in their city.

RESIDENTS SATISFIED WITH CITY PARKS

Over 80% of residents are satisfied with the City's parks, with only 18% of residents reporting that there are not enough parks in the City. Conversely, trails and recreation opportunities did not receive as high satisfaction ratings and have a higher proportion of residents who believe there are not enough of these amenities in South Jordan.

HALF OF RESIDENTS HAVE USE CITY PARKS A FEW TIMES A MONTH

Just over half of residents report visiting South Jordan City parks a few times a month or more. Residents in Districts 3, 4, and 5 report visiting City parks much more frequently than Districts 1 and 2. Residents with children and those who are newer to South Jordan visit City parks more often than those without children and longer-term South Jordan residents.

74% of residents with children report visiting City parks a few times a month or more, compared to 35% of residents without children. Newer South Jordan residents (those who have lived in the City 10 years or less) report visiting City parks more often than those who have lived in the City for 11+ years.

Nearly half of respondents (44%) report having visited City Park or one of the private parks in Daybreak in the past year. When it comes to parks that residents visit most often, private parks in Daybreak and Highland Park are the most popular.



When it comes to reasons for frequenting their most visited park, proximity to home is far and away the most common reason. Playground equipment is considerably more important for residents with children compared to those without children.




SHADE STRUCTURES MORE REQUESTED PARK IMPROVEMENT



When it comes to additions or improvements to City parks, residents most frequently mention wanting designated dog parks. The primary reason for wanting designated dog parks is to keep dog waste out of regular parks. Other popular requests include additional shade and better-maintained athletic courts.



FEW RESPONDENTS HAVE NEVER VISITED CITY PARK

Only 4% of respondents never having visited a City park. Among these, lack of interest is the primary reason for not visiting South Jordan City parks.

TRAILS

DISTRICT 5 USES CITY TRAILS THE MOST

Overall, 41% of residents use South Jordan City trails a few times a month or more and the vast majority use trails at least a few times a year. Residents who use trails more than average include residents from District 5, those with children, and higher-income residents (more than \$100k annually). Hiking/walking is the most popular activity on City trails, followed by biking (for recreation).

63% of residents from District 5 use City trails a few times a month or more compared to 49% from District 1, 21% from District 2, 35% from District 3, and 40% from District 4.

51% of residents with children report using City trails a few times a month or more, compared to 34% of residents without children. Residents who have an annual income of over \$100k visited City trails more often than those who make less than \$100k.


DAYBREAK & JORDAN RIVER TRAIL SYSTEMS MOST POPULAR



PROXIMITY TO HOME IMPORTANT REASON FOR VISITING CITY TRAILS

Proximity to home, scenery, and safety are the top reasons for residents visiting their favorite City trail. Those who prefer the Jordan River Parkway Trail enjoy that it supports their specific uses (biking, hiking, skateboarding, etc.), while users of the Oquirrh Trail find the connections to parks and multiple trailheads important.


Q: What are the most important reasons that [your most visited trail] is your most visited trail? Please select your top three reasons. (n = 342)



RESTROOMS MOST REQUESTED IMPROVEMENT FOR CITY TRAILS

When it comes to trail improvements, residents most commonly request restrooms, trail maintenance, trees/landscaping, and pet waste disposal stations. The Daybreak Trail System, which is the most visited City park, is reported to need additional lighting at the trailhead.


Q: In your opinion, what improvements should be made to [your most visited trail]? Please select up to three. (n = 335)



RESIDENTS NOT VISITING TRAILS DUE TO LACK OF INTEREST

Only 6% of residents never use or visit trails in South Jordan. Among those, disinterest in City trails is the main reason for not utilizing trails, followed by lack of ability, time, and information. By comparison, trail safety, features, and atmosphere are less important considerations.

ADDITIONAL SERVICES REQUESTED FOR BIKERS AND DOGS


42% of residents have experienced or witnessed conflicts with others (21% for bikers, 21% for dogs/their owners) while using South Jordan recreation services. The top solution suggested for bicycle conflicts is to establish policies for use of ebikes on City trails. The top solutions for dog/dog owner conflicts are to create a dedicated dog park or increase enforcement for not following current regulations.












LIVE MUSIC BIGGEST ENCOURAGEMENT TO VISIT CITY PARKS




FACILITIES, PROGRAMS, AND FUNDING

MINI GOLF MOST POPULAR ACTIVITY AT MULLIGANS






RESIDENTS FAVOR PICKLEBALL COURTS FOR FUNDING


RESIDENTS PRIORITIZE EXISTING PARKS/PLAYGROUNDS & TRAILS

When asked to allocate funds from a hypothetical budget, the options that had the highest average of money dedicated to them are existing parks and playgrounds, walking and biking trails, preservation of open space, and water-wise landscaping. Using funds for existing parks/playgrounds and walking/biking trails consistently received some fund allocation more than any other option.

MAJORITY OPPOSE PARK FEE

About half (51%) of respondents oppose the implementation of a "Park Fee" in South Jordan. Those that are especially opposed to this idea reside in Districts 2 or 4, do not have children, and have an annual income of under \$100k.

Several Utah cities have implemented a separate "Park Fee" to their monthly utility bill to meet the community's expectations for new and/or improved park resources, such as parks, trails, and programs. If South Jordan were to consider a Park Fee, would you support or oppose a \$5 per month (\$60 annually) "Park Fee"? (n=418)


Districts 2 and 4 are much more opposed to the "Park Fee" than the other districts. 56% of residents with children at least somewhat support South Jordan implementing a "Park Fee", compared to 25% of residents without children.

Residents with an annual salary of over \$100k are more likely to support a "Park Fee" than those who have an annual salary of under \$100k.









Public Input Approach








Projected Population Growth (2010-2050)

Neighborhood Parks ¹⁄₂-mile radius (typical walking distance for park a small variety of amenities)




Community Parks 1-mile radius (typical driving distance for park with a good variety amenities)




Regional Parks 2-mile radius (typical driving distance for park with significant amenities)


MAP 2 - SERVICE AREA + DISTRIBUTION EXISTING PARKS
