Attachment 1

Why do you want to serve on the Council?

My entire working life I have served in the public sector. Serving on the Town Council is a natural extension of my continuing commitment to public service. My academic and professional education has been public sector oriented (B.A. US Government, Norwich University [the oldest private military college in the US]; Masters of Public Administration, University of Georgia; Doctorate in Public Administration/Public Policy, University of Southern California and Graduate of the Industrial College of the Armed Forces, National Defense University [resource strategy and logistics] and some postdoc work at the Fletcher School of War and Diplomacy, Tufts University.

My work life has included increasingly more responsible Federal positions [see bio] in domestic and defense oriented agencies culminating in a Senior Executive Service [Highly Qualified Expert] position in the Department of the Army (Washington,DC). My 17 year stint at the National Defense University [graduate-level education] as a faculty member and department chair provided me with a breadth of experiences ranging from being an exchange faculty member to the Argentine War College to teaching National Security Strategy to senior military officers (O-5; O-6) and senior federal officials.

So how does this education and experience apply to a town council position? I have extensive insight into the following:

- I know how group, business and policy processes work. What works and what gets you into trouble. I used to teach the fundamental bases behind public policies.
- Expectation clarity folks will accept change only if it is clearly stated and communicated over a period of time in a transparent manner.
- "The capacity to budget is the capacity to govern" (Allen Shick, head of the Congressional Budget office). Budgeting reflects priorities and values.
- Change is hard (especially with an aging populace). Got to delineate concrete value propositions, costs and benefits.
- Provision of public goods (infrastructure, public safety, clean water and air,...) are hard and controversial. If they were easy the private sector would do them.
- Fair and open processes usually lead to better decisions.
- · Listening is an under-rated skill.

- Trust and professional integrity has to be woven into the fiber and fabric of the organization, in this case the Town Council and Town government.
- Leadership is about setting a clear vision, measuring progress towards that vision and giving others the credit.

I could go on but I think the above illustrates some of the knowledge, insight and experience I could conceivably bring to the Council. On a personal note, I try to live my life according to a simple mantra that I learned as a cadet at Norwich University: "A cadet will not lie, cheat, or steal or tolerate those who do." I can bring that attitude/action to the Council. On a lighter note, "I play well with others".

Dr. Robert E. Neilson was the Knowledge Management Advisor to the Army's Chief Information Officer (CIO/G-6). Formerly, he was the Chief Knowledge Officer (CKO), department chair and a professor at the Information Resources Management College (now iCollege), National Defense University. He has taught and lectured both in the U.S. and internationally including the Argentine War College, NATO Defense College, Italian Institute for Defense Studies, and in Asia and Australia. He has been a consultant with Computer Associates, DigitalNet, BAE, Brookings Institute, World Bank and federal agencies and has been a featured speaker at CIO and KM conferences domestically and internationally. He is one of the founders of the School of Information Warfare and Strategy, National Defense University which focuses on the information component of national power now better know as cyber operations.

He is a graduate of Norwich University (BA), University of Georgia (MPA) and University of Southern California (Doctorate), Industrial College of the Armed Forces, National Defense University. He is the author of "Sun Tzu and Information Warfare", "Collaborative Technologies and Organizational Learning" and numerous articles in academic journals and magazines. He was the author of the Army Knowledge Management Principles which was designed to transition the Army to a knowledge-enabled force.

Rob was named to the Federal 100 in 2010. He is on the Board of Kyield, a startup, that is using patented technology to create an enterprise operating system based on AI/ML.

His present interest is in conducting futuristic scenarios workshops for profit and non-profit organizations. Clients have ranged the gamut from federal agencies, US Army, corporations, universities, law firms to food pantries. His futuristic scenarios have been featured in "The Futurist".

Attachment 2

Why do you think you would be an asset to this Council?

In addition to the information and knowledge, skills, abilities and insight mentioned in the listing in Attachment 1 and my bio, I could be an asset to the Council in the following areas:

- Intergovernmental relations I am diplomatic enough to work in intergovernmental task forces representing the Town's interests.
- Even though Town staff write much of the communications and policy statements for the Town, I can review them from a high level perspective and provide guidance and editorial suggestions. Usually less is more. I can write coherent English.
- One unique skill I could bring to the Town is creating a future vision for the Town. If you look at my bio, I have run futuristic scenario workshops that envision how you may want to structure the physical infrastructure for the Town. I like to use the word "imagine". If you can't imagine it; you can't make it happen. For example, [for illustrative purposes only] Imagine if there was a public/private partnership to rebuild the MarketPlace into a Reston-like Town Center where Southern Shores citizens could congregate, eat at restaurants, shop at small and big shops, get health care, all in a bike, golf cart, or pedestrian and eco-friendly environment. It would be a win/win for citizens and the business community. I could run workshops to involve citizens to envision multiple futures for the town. I have run these workshops for the entire US Army, universities, think tanks, private sector corporations and even our local Food Pantry (gratis).
- Ably represent the Town at civic events and sporting events (Turkey trot, Surfing for Autism,...) w/o being a windbag.
- Other things that the Mayor wants me to do. To use a baseball analogy, I can function as a "utility infielder". I am multi-dimensional not uni-dimensional. I consider that an asset.

Attachment 3

Interests/Skills/Areas of Expertise/Volunteer Activities

I think I have covered most of the above topics in Attachments1 & 2 and in my bio but here are a few more:

- I am on the Board of Directors of KYield, a start-up firm based in New Mexico. It is focused on developing enterprise operations systems based on artificial intelligence and machine learning. Hence, I have a continuing interest in AI/ML.
- I am an avid cyclist and ride in long distance rides (Century rides, NYC 5 Boro Ride, ...) and a member of the OBX Silver Riders [we support the OBX Food Pantry and Bike to School]. I have volunteered to be the bike lead out for half and full marathons here on the OBX.
- I have written and published articles re: ways to make our elections more competitive and fairer and additional topics covering our present political environment.
- I continue to be a mediocre golfer but I show up and keep trying to improve.
- I am a voracious reader (The Economist, Atlantic, Harvard Business Review, Washington Post,....) and can bring ideas to the Council for consideration.
- I continue to support my wife's charity activities (Board of ICO, OBX Hospital Developmental Council, Board of Duck Woods CC, and Chair of the Get Pinked Committee [breast cancer awareness and services]. Someone has to stay home and mind the fort.

In sum, I have a wide range of knowledge, skills, abilities (KSA's) and most importantly insights from years of experience in the public sector. The public sector is fundamentally different than the private sector. Profit and fiduciary interest of stock holders are the underlying bases for business. The underlying basis for the public sector (The Town) is providing public goods to citizens in a fair and efficient manner as good stewards of taxpayers money while respecting property rights and privacy. I understand the difference between the two sectors and will act accordingly.

Why do you want to serve on the Southern Shores Town Council?

Thank you in advance for considering my application to serve on the Town Council.

My interest to serve on the Town Council is to give back to the community. My wife and I have lived in 9 different states during our lives, and we have chosen Southern Shores as our place to retire. We have always tried to serve the communities we have lived. In some cases, we were not there long enough to fully participate, but we always wanted to help and get involved in the places we have lived.

We were first introduced to the area in 1981 while living in the Shenandoah Valley. We bought our first home in KDH in 1988 and our second home in Southern Shores in 2000. We have lived permanently in Southern Shores since August of 2007. This is the longest we have lived in one location. Regardless of where we were living, we always came to the Outer Banks. When our children are asked where they are from, they say the Outer Banks, even though none of them ever lived here. It was the one constant in their lives, and they still come to visit us often, especially during the summer months.

My desire to serve on the Town Council is one of responsibility to make where you live and work, the best it can be. Southern Shores is unique in the fact that it's a community of folks who for the most part want to be here. My job up until Jan. 1 of 2020 took me away from the town and the state every week, sometimes for multiple weeks overseas. Now that I am retired from day-to-day responsibility, I am free now to engage with the community more fully in ways that I hope benefit the residents and visitors. I am a problem solver, an intense listener to all sides of a situation and have proven to be able to find compromise for most situations that sometimes, while not totally satisfactory for the parties involved, are reasonable solutions with common sense and respect for all individuals. It is also important to have vision of what can be! During my career in the food business, we needed to always be looking forward to seeing where the consumer was heading. That same principle applies to the town. Sometimes this can be controversial, but thoughts and ideas need to be vetted and listened to with an open mind and thought process. I want to bring that kind of thinking to the Town Council.

The town is full of individuals with varying backgrounds and experiences. Many are very qualified to serve on the Town Council. This adds to the uniqueness of the community. This is a strength that has been used well and I would like to offer my service to keep this key asset growing for the benefit of all.

Why do you think you would be an asset to this Town Council?

As mentioned before, we have lived in 9 states. While we moved many times due to my job, I always tried to get involved in the communities where we resided.

In McLouth Kansas I ran for city council and was elected. This was moons ago in the middle 70's. McLouth is a town of about 800 folks. Simple city government. We did own our utilities which provided us with tough choices. We had a full-time police department. It was a great learning experience. I also was a member of the Jaycee's, and we ran and hosted the annual Threshing Bee every August.

In Waynesboro Virginia I was on the Board of the Chamber of Commerce and was a Board member of the Waynesboro Community Hospital, a real learning experience as we were merging with another Hospital and the advent of Outpatient Surgery was just beginning to bloom, which led to tough decisions on Health Care for Augusta County, Va.

In Canton Ohio I was able to be on the Arts Council Board. Our time in Canton was short, 20 months; but I was able to get involved.

In Lansdale, Pa (suburb of Philadelphia) I was on our Church Board and chaired a building campaign for the church. My travel started to increase dramatically in Lansdale which prevented my involvement with further organizations. However, while there I started to be involved in more industry organizations like Food Industry Crusade against Hunger and the United Way.

In Oklahoma City my travel for work was extensive, almost daily, and while not involved in a major organization, I tried to support local causes as much as possible.

In Southlake Texas (between Dallas and Ft. Worth) I was not able to get involved in any organization because of travel and we were only there 10 months.

In Wilmington Delaware I volunteered with a local Tourist Railroad. Once I sold Clemens market and went to work for IGA, my travel became every week, Monday to Friday or longer. My office was in Chicago, but my responsibility was worldwide.

We moved to Southern Shores in August of 2007, and I traveled every week to Chicago and beyond till January 1 of 2020. I was gone at least Monday to Friday and with overseas travel 2 to 3 weeks at a time. However, I was able to help at Caring Hands from our church in Duck when able, but not as frequently as I would have liked like. That will change now that I am not actively employed.

While not active outside my job in civic and social areas during the last 20 years, I was just not able to participate because of my responsibilities with my job. Please don't take my comments as an excuse, but it was just the way it was.

What does all the above mean? I have been a part of many communities in many parts of the U.S and have experienced an education and immersion that I never dreamed possible. I think my experience with many culturally different people, being responsible for thousands of employees, and for management of Billions of Dollars in Sales and Millions in earnings and P+L's in different settings has provided me a foundation for listening, understanding, accountability, action and forward-looking thinking.

If you talk to any of my current and former colleagues, and friends, they will tell you this about me. "What you see is what you get". I have been characterized as plain spoken, my word is my bond, and my integrity is above reproach. If I make a mistake, I do everything I can to fix it. And I have made mistakes. They will also tell you I have an opinion, but I know how to build consensus and come to conclusions that work based on input from parties that I have had the privilege of working for and with.

In conclusion, I think my life experience has given me a wide perspective to learn every day, make sound decisions for the good of the community and the dedicated employees of Southern Shores.



MICHAEL "MIKE" GUARRACINO BIOGRAPHY

A nationally recognized expert with more than 44 years of military and government experience, Mike is the founder, President and CEO of Gray Wolf Associates, a Certified Small Disabled Veteran Owned Business and Duns and Bradstreet Verified consulting firm exclusively focused on the security sector. Prior to Gray Wolf, Mike served at the Supreme Court as the Deputy Marshal of the Court for Security where he was responsible for the development coordination and execution of security, continuity of government, executive protection, intelligence, and emergency preparedness programs for the protection of the Chief Justice, Associate Justices, Court employees, and over one million visitors a year.

Mike enlisted in the Navy in 1977 achieving the enlisted rank of Senior Chief and was commissioned in 1987. He participated in numerous national-level committees tasked to influence security policies and technology developments both within and outside the Department of Defense. For the Undersecretary of Defense for Acquisition and Technology, he independently provided senior management for the exploratory research and development of multimillion-dollar state-of-the-art programs related to combating terrorism. In 1993 with 16 years of active-duty service, Mike left active-duty and joined the Naval Reserves, retiring as the Executive Officer of the Navy Explosive Ordnance Technology Division in 2001, as a Commander select.

He conducted national-level terrorist related exercises and served as a senior technical advisor to the Secretary of Defense and Secretary of Energy regarding combating terrorism programs.

Following that Mike was appointed as the Deputy Director, Force Protection Directorate at the Defense Threat Reduction Agency (DTRA), were he played a lead role in the development of the Joint Staff Integrated Vulnerability Assessment Program (JSIVA) and the planning and execution of over five hundred worldwide JSIVAs and other select Special Assessments for the Chairman of the Joint Chiefs of Staff. In 1998, Mike's involvement with the program was instrumental in DTRA winning the Award of "Most Outstanding Antiterrorism Innovation/Action - DoD Component."
