4. **ACHD Update** – Kristy introduced Bella Loern of her staff as Transportation Planner. Bella will be attending next month's committee meeting. The Star Road Concept study has progressed to have an RFQ to do a technical review along with recommendations for impact fee funding (Project includes road widening, bridges, pathways and bicycle facilities from Hwy 44 to Hwy 20/26). The 5 year plan will go live tomorrow as a draft and asking for public to complete a survey. The Mayor asked Kristy to look at the school crossing lighting on Floating Feather. The lighting doesn't appear to meet the City's Dark Sky Initiative.
5. **Pathway Master Plan Update** – Tim Nicholson of Kimley Horn (KH) thanked the committee for their input on the latest version of the Master Plan. A revised draft of the plan will be submitted to City Staff and the Committee by September 12. It will issued to the public for comment on October 1. Final presentation to the City Council will be November 19.
